CONSTITUTION OF THE REPUBLIC OF FIJI
(Section 92(3))

MINISTERIAL ASSIGNMENT

To : Mr Parveen Kumar
Minister for Local Government, Housing, Environment, Infrastructure and Transport

WHEREAS, in exercise of the powers vested in me as Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I appointed you as the Minister for Local Government, Housing and Environment with effect from 24 September 2014 and assigned to you the responsibility for the conduct of Government business, departments and written laws specified in Legal Notice No. 47 of 2014.

NOW THEREFORE, in exercise of the powers vested in me as Prime Minister of the Republic of Fiji under section 92(3) of the Constitution of the Republic of Fiji, I hereby revoke with effect from 11 May 2015, all assignments and responsibilities under Legal Notice No. 46 of 2014 and Legal Notice No. 47 of 2014, and with effect from the same day assign to you in your capacity as the Minister for Local Government, Housing, Environment, Infrastructure and Transport, the responsibility for the conduct of the following Government business, departments and written laws (subject to the provisions of any other written law)—
