(EXECUTIVE AUTHORITY OF FIJI DECREE 2009 (Decree No. 2))

MINISTERIAL ASSIGNMENT

To: Mr Jocketani Cokanasiga
Acting Minister for Defence, National Security and Immigration

WHEREAS His Excellency Josefa Iloilovatu Uluivuda, in exercise of the powers vested in him as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree (Decree No. 2), and on the advice of the Prime Minister, had appointed Ratu Epeli Ganilau as Minister for Defence, National Security and Immigration with effect from the 11th day of April 2009 and assigned to you the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 4 of 2009;

AND WHEREAS the office, powers and functions of the President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces are now vested in His Excellency, Epeli Nailatikau ("the President") pursuant to Section 3A of the Executive Authority of Fiji Decree 2009;

AND WHEREAS, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji (Amendment) Decree 2009 (Decree No. 28), I revoked with effect from the 1st day of January, 2010, all assignments of responsibilities as recited above, in Legal Notice No. 4 of 2009 and with effect from the same day assigned Ratu Epeli Ganilau, as the Minister for Defence, National Security and Immigration, the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 60 of 2010;

NOW THEREFORE, in exercise of the powers vested in me as the President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji (Amendment) Decree 2009 (Decree No. 28), I hereby revoke with effect from the 17th day of November, 2010, all assignments of responsibilities assigned to Ratu Epeli Ganilau as recited in Legal Notice No. 60 of 2010, and with effect from the same day assign to you in your current capacity as the Acting Minister for Defence, National Security and Immigration, the responsibility for the conduct of the following Government business and departments and for the following written laws (subject to the provisions of any other laws)—
