

AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 5-21, 6-114, and 7-16, by repealing section 205 in its entirety, and by adding a new section 205 in lieu thereof, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 205 of title 52 of the Code of the Federated
 2 States of Micronesia is hereby repealed in its entirety.

3 Section 2. Title 52 of the Code of the Federated States of
 4 Micronesia is hereby further amended by adding a new section 205 to
 5 read as follows:

4 The provisions of this schedule shall not operate to
 5 decrease the base salary biweekly rate of employees
 6 employed on the effective date of the amending act codified
 7 in this section. Furthermore, the base salary biweekly
 8 rate of such employees shall not be increased beyond the
 9 rate in effect on the effective date of the amending act
 10 codified in this section."

11 Section 3. This act shall become effective on January 1, 1993.

12 Section 4. This act shall become law upon approval by the
 13 President of the Federated States of Micronesia or upon its becoming
 14 law without such approval.
