

AN ACT

To appropriate the sum of \$750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment, referral programs, and construction and renovation of dispensaries in all of the four States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF
MICRONESIA:

Section 1. The sum of \$400,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment, referral programs, and construction and renovation of dispensaries in the State of Chuuk to be apportioned as follows:

(1)	Chuuk Hospital	\$	130,000
(2)	Faichuk		65,000
(3)	Southern Namoneas		65,000
(4)	Northern Namoneas		55,000
(5)	Mortlocks		50,000
(6)	Northwest Islands		35,000

Section 2. The sum of \$200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for pharmaceutical supplies, lab and dental equipment, and referral programs in the State of Pohnpei.

Section 3. The sum of \$100,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for medical supplies, equipment, and referral programs in the State of Yap.

Section 4. The sum of \$50,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for medical supplies, equipment, and referral programs in the State of Kosrae.

Section 5. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. All funds appropriated herein shall not lapse until fully expended. The allottee of funds appropriated under subsection (1) of

section 1 of this act shall be the Director of Health Services, Chuuk State. The allottee of funds appropriated under subsection (2) of section 1 of this act shall be the PWP Authority. The allottee of funds appropriated under subsection (3) of section 1 of this act shall be the Southern Namoneas Authority. The allottee of funds appropriated under subsection (4) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of funds appropriated under subsection (5) of section 1 of this act shall be the Mortlocks Development Authority. The allottee of funds appropriated under subsection (6) of section 1 of this act shall be the Pattiw Development Authority. The allottee of funds appropriated under section 2 of this act shall be the Governor of Pohnpei State. The allottee of funds appropriated under section 3 of this act shall be the Governor of Yap State. The allottee of funds appropriated under section 4 of this act shall be the Governor of Kosrae State.

Section 6. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
