

AN ACT

To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121, 19-05, 19-34, 19-57 and 19-74, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 18-99, as amended by
2 Public Laws Nos. 18-113, 18-121, 19-05 and 19-34, is hereby further
3 amended to read as follows:

4 “Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State or his designee. The allottee of funds
16 appropriated under section 3 shall be the President or
17 his designee, EXCEPT THAT the allottee of funds

1 appropriated under section 3(a), (b), (c), (d), (e),
2 (f), (g), (h), (i), (j), (k), (l), (m), (n), (o) and (u)
3 shall be the Mayor of Lelu Town Government. The
4 allottee of funds appropriated under section 4 of this
5 act shall be the President or his designee, EXCEPT that
6 the allottee of funds appropriated under section 4(1)(a)
7 shall be the Secretary of the Department of Education;
8 the allottee of funds appropriated under sections
9 4(1)(c), 4(1)(e), 4(1)(h) and 4(2) shall be Secretary of
10 the Department of Transportation, Communications and
11 Infrastructure; the allottee of funds appropriated under
12 section 4(1)(d) shall be the Pohnpei Port Authority; the
13 allottee of funds appropriated under section 4(1)(f)
14 shall be the Nett District Government; the allottee of
15 funds appropriated under section 4(1)(g) shall be the
16 Secretary of the Department of Resources and
17 Development; the allottee of funds appropriated under
18 sections 4(3)(b) and 4(4)(a) shall be the Pohnpei
19 Transportation Authority and the allottee of funds
20 appropriated under section 4(3)(g) shall be the COM-FSM
21 Cooperative Extension Service. The allottee of funds
22 appropriated under sections 5(1), 5(3) and 5(6) of this
23 act shall be the Governor of Chuuk State or his
24 designee. The allottee of funds appropriated under
25 subsection 5(2) of this act shall be the Mortlock

1 Islands Development Authority. The allottee of funds
2 appropriated under subsection 5(4) of this act shall be
3 the Southern Namoneas Development Authority. The
4 allottee of funds appropriated under subsection 5(5) of
5 this act shall be the Faichuk Development Authority.
6 The authority of the allottee to obligate funds
7 appropriated by this act shall lapse on September 30,
8 2018.”

9 Section 2. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
