

AN ACT

To amend Public Law No. 2-35 to appropriate the sum of \$637,600 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-35 is hereby amended to  
2 read as follows:

3 "Section 1. Appropriation. The sum of \$637,600, or so much  
4 thereof as may be necessary, is hereby appropriated from the  
5 General Fund of the Federated States of Micronesia for the  
6 fiscal year ending September 30, 1982, for the purpose of  
7 funding public projects in the State of Ponape. The sum appro-  
8 priated shall be apportioned in the following manner:
