

AN ACT

To further amend Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164, 20-190, 21-05, 21-33, 21-48, 21-67 and 21-91, by amending sections 4, 5 and 6 thereof, to change use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-141, as amended
2 by Public Laws Nos. 20-163, 20-190, 21-05, 21-48 and 21-67, is
3 hereby further amended to read as follows:

 14 Public Laws Nos. 20-163, 20-164, 20-190, 21-05, 21-33, 21-48 and
 15 21-91, is hereby further amended to read as follows:

16 "Section 6. Allotment and management of funds and
 17 lapse date. All funds appropriated by this act shall
 18 be allotted, managed, administered and accounted for in
 19 accordance with applicable laws, including, but not
 20 limited to, the Financial Management Act of 1979. The
 21 allottee shall be responsible for ensuring that these
 22 funds, or so much thereof as may be necessary, are used
 23 solely for the purpose specified in this act, and that
 24 no obligations are incurred in excess of the sum
 25 appropriated. The allottee of the funds appropriated

1 under section 2 of this act shall be the Governor of
2 Yap State or his designee PROVIDED THAT the allottee of
3 funds appropriated under subsections 2(a) and 2(b) of
4 this act shall be the President of the Federated States
5 of Micronesia or his designee. The allottee of the
6 funds appropriated under sections 3 and 4 of this act
7 shall be the President of the Federated States of
8 Micronesia or his designee; PROVIDED THAT, the allottee
9 of funds appropriated under subsections 3(a), 3(b),
10 3(c), 3(e), 3(f), 3(g), 3(h), 3(j), 3(k), 3(l), 3(m),
11 3(n), 3(o), 3(p), 3(q), 3(s), 3(t), 3(u), 3(v), 3(w),
12 3(x), 3(y), 3(z), 3(a3) to 3(a10), 3(a30) and 3(a31) of
13 this act shall be the Mayor of Lelu Town Government or
14 his designee; the allottee of funds appropriated under
15 subsections 3(d), 3(i), 3(r), 3(a2) and 3(a11) to
16 3(a25) of this act shall be the Mayor of Tafunsak
17 Municipal Government or his designee; the allottee the
18 allottee of funds appropriated under subsections (a27),
19 (a28) and (a29) of this act shall be the Governor of
20 Kosrae State or his designee; the allottee of funds
21 appropriated under subsection 3(a26) is the Secretary
22 of the FSM Department of Education or his designee; the
23 allottee of funds appropriated under subsection 4(1)(v)
24 of this act shall be the Meninkeder lapalap of
25 Madolenihmw Municipal Government or his designee; the

1 allottee of funds appropriated under subsection 4(1)(w)
2 of this act shall be the Chief Minister of U Municipal
3 Government or his designee; the allottee of funds
4 appropriated under subsections 4(1)(x) and 4(4)(n) of
5 this act shall be the District Administrator of Nett
6 Municipal Government or his designee; the allottee of
7 funds appropriated under subsection 4(1)(y) of this act
8 shall be the Luhken Menlap of Kitti Municipal
9 Government or his designee; the allottee of funds
10 appropriated under subsection 4(1)(z) of this act shall
11 be the Chief Magistrate of Sokehs Municipal Government
12 or his designee; the allottee of funds appropriated
13 under subsections 4(2)(a) to 4(2)(s), 4(2)(ab),
14 4(3)(a), 4(3)(b), 4(3)(c), 4(3)(d), 4(3)(k), 4(3)(x),
15 4(4)(a), 4(4)(b), 4(4)(c), 4(4)(d), 4(4)(g), 4(4)(h),
16 4(4)(i), 4(4)(j) and 4(4)(k) of this act shall be the
17 Pohnpei Transportation Authority (PTA) except that the
18 allottee of funds appropriated under subsection 4(2)(l)
19 of this act shall be the Administrator of MiCare
20 program or her designee; the allottee of funds
21 appropriated under subsection 4(3)(n) of this act shall
22 be the Secretary of the Department of Health and Social
23 Affairs or her designee, the allottee of funds
24 appropriated under subsections 4(2)(h), 4(2)(q),
25 4(2)(u), 4(2)(ac), 4(2)(v), 4(2)(w), 4(2)(x), and

1 4(2)(z) of this act shall be the Secretary of the
2 Department of Transportation, Communications and
3 Infrastructure or his designee; the allottee of funds
4 appropriated under subsection 4(2)(y) of this act shall
5 be the Pohnpei Port Authority; the allottee of funds
6 appropriated under subsection 4(2)(aa) of this act
7 shall be the Chief Magistrate of Sokehs Municipal
8 Government or his designee; the allottee of fund
9 appropriated under subsections 4(1)(a2) and 4(4)(l) of
10 this act shall be the Mayor of Pingelap Municipal
11 Government; the allottee of funds appropriated under
12 subsections 4(1)(a1) and 4(4)(m) of this act shall be
13 the Chief Magistrate of Mwoakilloa Municipal
14 Government; the allottee of funds appropriated under
15 subsection 4(1)(a3) of this act shall be the Luhken
16 Kolwof of Sapuwafik Municipal Government; the allottee
17 of funds appropriated under subsection 4(1)(a4) of this
18 act shall be the Mayor of Nukuoro Municipal Government;
19 the allottee of funds appropriated under subsection
20 4(1)(a5) of this act shall be the Chief Magistrate of
21 Kapingamarangi Municipal Government; the allottee of
22 funds appropriated under subsections 4(3)(e), 4(3)(f),
23 4(3)(j), 4(3)(p), 4(3)(w) and 4(3)(z) of this act shall
24 be the Menin Keder Lapalap of Madolenihmw; the allottee
25 of funds appropriated 4(3)(a5) shall be the Secretary

1 of the Department of Health and Social Affairs. The
2 allottee of the funds appropriated sections 5 of this
3 act shall be the Governor of Chuuk State or his
4 designee; PROVIDED THAT, the allottee of funds
5 appropriated under subsections 5(g) and 5(j) of this
6 act shall be the FSM Telecommunication Corporation or
7 its designee and the allottee of funds appropriated
8 under subsections 5(d) and 5(e) of this act shall be
9 the FSM Secretary of the Department of Transportation,
10 Communications and Infrastructure or his designee. The
11 authority of the allottee to obligate funds
12 appropriated by this act shall lapse on September 30,
13 2021."

14 Section 4. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
