

AN ACT

To amend sections 1, 3, 8, 9, and 12 of Public Law No. 21-185, to appropriate \$765,000 of additional funds from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, to provide funding for the Federated States of Micronesia's membership fees and activities in INTERPOL and to fund the COM-FSM Endowment Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 1 of Public Law No. 21-185 is hereby  
2 amended to read as follows:

3           "Section 1. Purpose. The purpose of this act is to  
4 appropriate the sum of \$64,525,467 from the General Fund  
5 of the Federated States of Micronesia for the fiscal year  
6 ending September 30, 2021, for the purpose of funding the  
7 operations of all branches of the National Government of  
8 the Federated States of Micronesia, its agencies, various  
9 programs, grants, subsidies and contributions and Capital  
10 and Human Resources Development. The National  
11 Government's share of the Amended Compact funds has been  
12 reduced to zero; EXCEPT THAT; the National Government  
13 will retain the Compact Sector Grant amount for COM-FSM  
14 and 10 percent of the Supplemental Education Grant funds  
15 as is reflected in the budget for the Department of  
16 Education. The sum appropriated herein shall be  
17 apportioned as follows:"

18           Section 2. Section 3 of Public Law No. 21-185 is hereby

1 amended to read as follows:

2           “Section 3. Operating Expenses of the Legislative  
 3           Branch. The sum of \$6,095,625, or so much thereof as  
 4           may be necessary, is hereby appropriated from the  
 5           General Fund of the Federated States of Micronesia for  
 6           the fiscal year ending September 30, 2021, for the  
 7           operations of the Legislative Branch of the National  
 8           Government during fiscal year 2021. The sum  
 9           appropriated by this section shall be apportioned as  
 10          follows:

 13           necessary, for the operations of the Office of the  
 14           Speaker and Members of the Congress of the Federated

2 Section 5. Section 12 of Public Law No. 21-185 is  
3 hereby amended to read as follows:

4 "Section 12. Allotment and Management of Funds and  
5 Lapse Dates.

6 (1) General provisions.

7 (a) All funds appropriated by this act shall  
8 be allotted, managed, administered and accounted for in  
9 accordance with applicable law, including, but not limited to,  
10 the Financial Management Act of 1979.

11 (b) The allottees shall be responsible for  
12 ensuring that these funds, or so much thereof as may be  
13 necessary, are used solely for the purposes specified in this  
14 act, and that no obligations are incurred in excess of the sums  
15 appropriated.

16 (2) Allottees. The allottees of the funds  
17 appropriated by this act are as follows:

18 (a) Section 2 - the allottee of these funds  
19 shall be the President of the Federated States of Micronesia;

20 (b) Section 3 - the allottee of these funds  
21 shall be the Speaker of the Congress of the Federated States of  
22 Micronesia;

23 (c) Section 4 - the allottee of these funds  
24 shall be the Chief Justice of the Supreme Court of the Federated  
25 States of Micronesia;

1 (d) Section 5 – the allottee of these funds  
2 shall be the Public Auditor of the Federated States of  
3 Micronesia;

4 (e) Sections 6 through 9 – the allottee of  
5 these funds shall be the President of the Federated States of  
6 Micronesia; PROVIDED, HOWEVER, that for the following  
7 subsections of sections 8 through 9 of this act:

8 (i) Sections 8(1)(f) and 8(13)(q) – the  
9 allottee of these funds shall be the Chair of the Joint  
10 Committee on Compact Review and Planning;

11 (ii) Section 8(8)(a) – the allottee of  
12 these funds shall be the Governor of the state of Kosrae;

13 (iii) Section 8(8)(b) – the allottee of  
14 these funds shall be the Governor of the state of Pohnpei;

15 (iv) Section 8(8)(c) – the allottee of  
16 these funds shall be the Governor of the state of Chuuk;

17 (v) Section 8(8)(d) – the allottee of  
18 these funds shall be the Governor of the state of Yap;

19 (vi) Section 8(11) – the allottee of these  
20 funds shall be the Public Auditor of the Federated States of  
21 Micronesia;

22 (vii) Section 8(12) – the allottee of these  
23 funds shall be the Speaker of the Congress of the Federated  
24 States of Micronesia;

25 (viii) Section 8(13)(a) – the allottee of

1 these funds shall be the President of the College of Micronesia-  
2 FSM;

3 (ix) Section 8(13)(d) through (g) - the  
4 allottee of these funds shall be the Chief Justice of the  
5 respective State Supreme Court;

6 (x) Section 8(13)(h) - the allottee of  
7 these funds shall be the Chief Justice of the Supreme Court of  
8 the Federated States of Micronesia;

9 (xi) Section 8(13)(t) - the allottee of  
10 these funds shall be the National Olympic Committee;

11 (xii) Section 8(13)(u) - the allottee of  
12 these funds shall be the Principal of Saint Cecilia Catholic  
13 School;

14 (xiii) Section 9(1) - the allottee of  
15 these funds shall be the President of the College of Micronesia-  
16 FSM;

17 (xiv) Section 9(3)(b) - the allottee of  
18 these funds shall be the Governor of the state of Kosrae;

19 (xv) Section 9(3)(c) - the allottee of  
20 these funds shall be the Governor of the state of Pohnpei;

21 (xvi) Section 9(3)(d) - the allottee of  
22 these funds shall be the Governor of the state of Chuuk;

23 (xvii) Section 9(3)(e) - the allottee of  
24 these funds shall be the Governor of the state of Yap;

25 (xviii) Section 9(4)(i) - the allottee of

1 these funds shall be the Secretary of the Department of  
2 Transportation, Communications and Infrastructure;

3 (xix) Section 9(11)(b) – the allottee of these  
4 funds shall be the Speaker of the Congress of the Federated  
5 States of Micronesia;

6 (xx) Section 9(11)(d) – the allottee of these  
7 funds shall be the President of the Constitutional Convention;

8 (xxi) Section 9(11)(f) – the allottee of these  
9 funds shall be the Governor of the state of Chuuk; and

10 (xxii) Section 9(11)(g) – the allottee of these  
11 funds shall be the Secretary of the Department of  
12 Transportation, Communications and Infrastructure.

13 (xxiii) Section 8(13)(r) the allottee of these  
14 funds shall be the Governor of the State of Yap.”

15 Section 6. This act shall become law upon approval by the  
16 President of the Federated States of Micronesia or upon its  
17 becoming law without such approval.
