CONGRESSIONAL BILL NO. 3-225, C.D.1, C.D.2,
C.D.3, C.D.4

AN ACT

To appropriate the sum of \$3,747,466 from the General Fund of the Federated States of Micronesia and the sum of \$6,791,081 from the United States Grant Special Fund for the fiscal year ending September 30, 1985, for the operations of the executive branch, legislative branch, National judiciary, Public Auditor, agencies of the National Government, and for special programs, contributions, grants, subsidies, and refunds of the National Government during fiscal year 1985; to establish employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Operating expenses of the executive branch. The sum
2 of \$5,656,915, or so much thereof as may be necessary, is hereby
3 appropriated from the United States Grant Special Fund for the fiscal
4 year ending September 30, 1985, for the operations of the executive
5 branch of the National Government of the Federated States of Micronesia
6 during fiscal year 1985. The sums appropriated by this section shall be
7 apportioned as follows:

9 the Federated States of Micronesia during fiscal year 1985. The

9 year ending September 30, 1985, for the operations of the National judi-
10 ciary of the Federated States of Micronesia during fiscal year 1985. The

9 necessary, is hereby appropriated from the General Fund of the
10 Federated States of Micronesia and the sum of \$312,109, or so much
11 thereof as may be necessary, is hereby appropriated from the United
12 States Grant Special Fund for the fiscal year ending September 30,
13 1985, for the operations of independent agencies, commissions,
14 authorities, boards, bureaus, and other organizations of the National
15 Government of the Federated States of Micronesia during fiscal year

10 as may be necessary, is hereby appropriated from the General Fund of
11 the Federated States of Micronesia for the fiscal year ending September
12 30, 1985, for special programs, grants, subsidies, contributions,
13 and refunds of the National Government of the Federated States of
14 Micronesia during fiscal year 1985. The sums appropriated by this
15 section shall be apportioned as follows:

2 (2) The number of positions authorized applies individually to
3 each of the departments and offices of the executive and legislative
4 branches, the National judiciary, the Public Auditor, and to the agencies
5 as provided in subsection (1) of this section, except that the President
6 may transfer up to 12 positions between the departments and offices of
7 the executive branch. This authorization of positions covers all
8 permanent employees, all contract personnel whose employment extends for
9 1 year or more, and all positions funded from United States federal
10 programs. No funds may be expended for unbudgeted positions.

11 Section 8. Reprogramming.

12 (1) The President or his designee may reprogram up to 10 percent
13 to and from the funds appropriated to each of the subsections in section 1,
14 and may reprogram up to 15 percent to and from the funds appropriated
15 in each of the paragraphs within the subsections of section 1.

16 (2) The Speaker or his designee may reprogram up to 10 percent
17 to and from the funds appropriated to each of the subsections in section 2,
18 and may reprogram up to 15 percent to and from the funds appropriated
19 in each of the paragraphs within the subsections of section 2.

20 (3) The Chief Justice or his designee may reprogram up to
21 15 percent to and from the funds appropriated in each of the subsections
22 in section 3.

23 (4) The Public Auditor may reprogram up to 15 percent to and from
24 the funds appropriated in each of the subsections in section 4.

25 (5) Allottees of funds may reprogram up to 15 percent to and

1 from the funds appropriated in each of the paragraphs within the subsec-
2 tions of section 5.

3 Section 9. Allotment and management of funds and lapse date.

4 All funds appropriated by this act shall be allotted, managed, admin-
5 istered, and accounted for in accordance with applicable law, including,
6 but not limited to, the Financial Management Act of 1979, as amended.

7 The allottee shall be responsible for ensuring that these funds, or so
8 much thereof as may be necessary, are used solely for the purposes
9 specified in this act, and that no obligations are incurred in excess of
10 the sum appropriated. The authority of the allottee to obligate funds
11 appropriated by this act, except those appropriated by sections 5(6)
12 and 6(3), shall lapse as of September 30, 1985.

13 Section 10. Effective date. This act shall become law upon
14 approval by the President of the Federated States of Micronesia or
15 upon its becoming law without such approval.


