

AN ACT

To amend section 1 of Public Law No. 3-56, Truk State public projects, for the purpose of reapportioning funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-56 is hereby
2 amended to read as follows:

3 "Section 1. The sum of \$789,700, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund
5 of the Federated States of Micronesia for the fiscal year
6 ending September 30, 1985, for the purpose of funding public
7 projects in the State of Truk. The sum appropriated herein
8 shall be apportioned as follows:
