

PRESIDENTIAL COMM. NO. 4-102  
FSM CONGRESS

AN ACT

To further amend Public Law No. 4-11, as amended by Public Law No. 4-12, by amending sections 1, 2, 3, 4, 5, 6 and 7, for the purpose of appropriating the sum of \$715,195 from the General Fund of the Federated States of Micronesia and the sum of \$135,858 from the United States Grant Special Fund for the fiscal year ending September 30, 1986, as supplemental funding for the Office of the President, the Department of External Affairs, the Department of Social Services, the Department of Resources and Development, the Office of the Attorney General, the Office of Planning and Statistics, the legislative branch, the National judiciary, the Public Auditor, the Micronesian Maritime Authority, the Coconut Development Authority, the FSM Board of Education, the T3 program, the MTAP program, the census, and medical supplies; adjusting the employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 4-11 is hereby amended to



10 (2) The number of positions authorized applies  
11 individually to each of the departments and offices of  
12 the executive and legislative branches, the National  
13 judiciary, the Public Auditor, and to the agencies as  
14 provided in subsection (1) of this section, except that  
15 the President may transfer up to 12 positions between the  
16 departments and offices of the executive branch. This  
17 authorization of positions covers all permanent employees,  
18 all contract personnel whose employment extends for 1 year  
19 or more, and all positions funded from United States  
20 federal programs. No funds may be expended for unbudgeted  
21 positions."

1 Section 8. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its becoming  
3 law without such approval.
