

AN ACT

To appropriate the sum of \$180,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$180,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1989, for the purpose of funding certain public projects in the
5 State of Truk. The funds appropriated by this act shall be deemed to
6 have come from the capital account of the Compact of Free Association.

7 Section 2. The sum appropriated under section 1 of this act
8 shall be apportioned as follows:

- 9 (1) Ta Airport project \$ 70,000
- 10 (2) Ulul Airport project 40,000
- 11 ~~(3) Mortlock Junior High School improvement 10,000~~ *Vetoed GRH*
- 12 ~~(4) Southern Namoneas Junior High~~
- 13 ~~School improvement 10,000~~ *Vetoed GRH*
- 14 ~~(5) Hall Islands Junior High School~~
- 15 ~~construction 20,000~~ *Vetoed GRH*
- 16 ~~(6) Faichuk Junior High School improvement 10,000~~ *Vetoed GRH*
- 17 ~~(7) Moen Junior High School improvement 10,000~~ *Vetoed GRH*
- 18 ~~(8) Vehicle - Project administration 7,000~~ *Vetoed GRH*
- 19 ~~(9) Boat - Project administration 3,000~~ *Vetoed GRH*

20 Section 3. All funds appropriated by this act shall be allotted,
21 managed, administered, and accounted for in accordance with applicable
22 law, including, but not limited to, the Financial Management Act of

1 1979. The allottee for the funds appropriated under subsections (1)
2 and (2) of section 2 of this act shall be the President of the
3 Federated States of Micronesia, and the allottee for the
4 funds appropriated under subsections (3), (4), (5), (6), (7), (8),
5 and (9) of section 2 of this act shall be the Governor of the State
6 of Truk. Each allottee shall be responsible for ensuring that
7 these funds, or so much thereof as may be necessary, are used solely
8 for the purposes specified in this act, and that no obligations are
9 incurred in excess of the sum appropriated. The authority of the
10 allottees to obligate funds appropriated by this act shall lapse as of
11 September 30, 1989.

12 Section 4. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
