CONGRESSIONAL BILL No. 6-333

Public Law No. 6 - 1 1 3

AN ACT

To appropriate the sum of \$25,297 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991, for the purpose of reappropriating certain lapsed funds for Madolenihmw and Kitti public projects and programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$17,070, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1991, for the purpose of funding Madolenihmw public projects and
5 programs. The funds appropriated under this section shall be
6 apportioned as follows:

18 Section 2. The sum of \$8,227, or so much thereof as may be
19 necessary, is hereby appropriated from the General Fund of the Federated
20 States of Micronesia for the fiscal year ending September 30, 1991,
21 for the purpose of funding Kitti public projects and programs. The
22 funds appropriated under this section shall be apportioned as follows:

12 Section 3. All funds appropriated by this act shall be
13 allotted, managed, administered, and accounted for in accordance with
14 applicable law, including, but not limited to, the Financial
15 Management Act of 1979. The allottee of the funds appropriated under
16 section 1 of this act shall be the Menin Keder Lapalap of the
17 Madolenihmw Municipal Government, except for those funds appropriated
18 under subsection (7) of section 1 of this act for which the allottee
19 shall be the Menin Keder Lapalap of the Madolenihmw Municipal
20 Government and the Menin Tiensapw of Madolenihmw. The allottee of
21 the funds appropriated under section 2 of this act shall be the
22 Luhken Menlap of the Kitti Municipal Government, except for those
23 funds appropriated under subsection (7) of section 2 of this act for
24 which the allottee shall be the Luhken Menlap of the Kitti Municipal
25 Government and the Isokohnedi of Kitti. The allottees shall be



1 responsible for ensuring that these funds, or so much thereof as may
2 be necessary, are used solely for the purposes specified in this act,
3 and that no obligations are incurred in excess of the sum
4 appropriated. The authority of the allottees to obligate funds
5 appropriated by this act shall not lapse.

6 Section 4. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its becoming
8 law without such approval.
