CUSTOMS ACT 1993 (Section 4)

TARIFF ORDER IN RELATION TO GOODS IMPORTED BY TELECOM SERVICES KIRI-BATI LIMITED

In exercise of the power vested in me by Section 4 of the Customs Act 1993, I, acting in accordance with the advice of the Cabinet, hereby exempt from the payment of Import duty on the following goods:

All capital items required by Telecom Services Kiriabti Limited for the Purposes of carrying out the objectives of the Company as set out in clause 3 of the agreement between the Government of Kiribati and Telstra dated 1 November 1990, subject to the following conditions:-

- They are used exlusively by TSKL for the specified purposes they have applied for;
- (2) They are not sold or transferred to a differ ent person or functionary unless mutually agreed by both parties;
- (3) That an itemised list of all plants, equip ment and other capital items to be imported are submitted to Customs in ample time to allow timely release;
- (4) Provided the foregoing conditions are duly observed then the goods shall become sub ject to the full duty or lower rate whichever is applicable.

This order shall be deemed to have come into force on the 1st day of January 1993 and to be limited to the period of the agreement between Government and Telstra.
