# BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS

### Section 1. Short Title.

This Act may be cited as the Civil Procedure (Amendment) Act of 2002.

### Section 2. **Amendments**

- Section 139 of the Civil Procedure Act, 29 MIRC Chp. 1 ("Civil Procedure Act"), (1) is repealed and in its place is inserted a new Section 139 that reads as follows:
  - §139. Allocation of costs.

All fees and expenses paid or incurred under this Part or by court rule by any party prevailing in any matter, other than a criminal proceeding, shall be taxed as part of the costs against the losing party or parties unless the Court shall otherwise order; provided, that no fees paid to a witness who is a party-in-interest and is called and examined on his own behalf or on behalf of others jointly interested with him shall be allowed or taxed as costs; and provided further that no costs shall be taxed against the Republic or any of its agencies or local governments.

Section 140 of the Civil Procedure Act is repealed and in its place is inserted a new (2)
