7	Section 1. Short Title			
8	This Act may be cited as the Elections and Referenda (Voter Identification Card			
9	Amendment) Act, 2004.			
10	Section 2. Amendment			
11	Section 133 and 173(1)(a) of the Act are hereby amended as follows;			
12	(1) Section 133 is hereby amended in the following manner;			
13	§133. Registration and Issuance of Voter Identification Number			
14	(1) If the member of a Board of Elections or person authorized to administer oaths to			
15	whom application is made under Section 132 of this Chapter is satisfied, based on the content of			
16	the application, that the applicant is entitled to be entered in the Register, he shall approve the			
17	application and forward it to the Chief Electoral Officer for the necessary entry in the Register.			
18	(2) If, after giving the applicant an opportunity to be heard or to bring evidence on the			
19	matter, the Chief Electoral Officer is not satisfied that an applicant is entitled to be entered in the			
20	Register in accordance with the application, he may reject the application, but otherwise he shall

1	enter the applicant in the Register.
2	(3) Upon registration of the applicant as anticipated under subsection (1) above, the Chief
3	Electoral Officer shall issue the applicant with a voter identification number. Such identification
4	number shall be displayed on the voters national identification card.
5	(2) Section 173 (1)(a) is hereby amended as follows;
6	§173. Voting.
7	(1) When a person enters a polling place to vote:
8	(a) he shall state his name in full and his address to the election officials,
9	and present to the official for examination, his or her national identification card;
10	and
11	
12	Section 3. Effective Date
13	This Act shall take effect on the date of certification in accordance with Article IV
14	Section 21 of the Constitution and the Rules and Procedures of the Nitijela.
