**AN ACT**

1 to amend the Education Act, 1991 (14 MIRC Chapter 1) section 317 to require all pre-school,  
2 level schools, elementary level schools, secondary level schools and tertiary level institutions to  
3 teach the Marshallese language, custom and culture, and history.

5 **BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS**

6 **Section 1. Short Title**

7 This Act may be cited as the Education (Marshallese Language and Custom Amendment)  
8 Act, 2003.

9 **Section 2. Amendment**

10 The Education Act, 1991 (14 MIRC Chapter 3) section 317 is hereby amended to read in  
11 the following manner;

12 **§317. Curriculum**

13 (1) The Ministry shall establish minimum standards for instruction,  
14 curriculum development, and content of courses at appropriate levels to promote  
15 uniform levels of achievement.

16 (2) Instruction in the Marshallese language, custom culture and history  
17 shall be compulsory, and shall be provided at all pre-school level schools,  
18 elementary level schools, secondary levels schools and tertiary and college level  
19 institutions. Instructions shall include assessment of student needs, selection of

1 appropriate learning activities, methodologies and materials and evaluation of the  
2 student's attainment of objectives. The curriculum shall permit continuous  
3 progress along sequential lines of development in academic as well as vocational  
4 areas. The curriculum shall be of sufficient depth and breadth to meet the needs,  
5 interests and abilities of the students in that particular community.

6 (3) All secondary level students in the Republic shall be required to pass  
7 an examination on the Marshallese language, custom, culture and history, in  
8 order to obtain a secondary education diploma or certificate.

9 (4) The Ministry of Education shall develop a course on the Marshallese  
10 language, custom, culture and history, to be known as Marshallese Studies for the  
11 purposes of this section .

12  
13 Section 3 **Effective Date**

14 This Act shall take effect upon certification, in accordance with Article IV Section 21 of  
15 the Constitution of the Republic of the Marshall Islands and the Rules and Procedures of the  
16 Nitijela.




