§908 Memorial Day and Nuclear Survivors Remembrance Day Holiday

14In commemoration of, and as a tribute to all those who suffered and15continue to suffer as a result of the United States Nuclear Testing Program in the16Marshall Islands at the end of World War II, the national flag shall be flown at17half-staff on March 1st each year to coincide with the Memorial Day and Nuclear18Survivors Remembrance Day holiday.19(2) By amending the Schedule to the Public Holidays Act, 1988, setting out the annual20holidays in the Republic, by renaming the March 1st holiday in the following manner;
