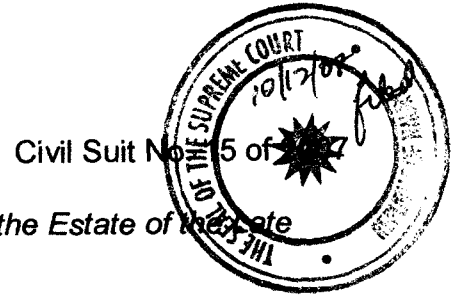

**ORDER FOR ATTACHMENT OF RONWAN INTEREST**

**IT IS ORDERED** by the Court that:

1. All payments and debts due and accruing to the Respondent from the Garnishee, from all such moneys at present in the possession of the Garnishee as part of the 'Ronwan Interest' payable to the Respondent under section 19(5) of the *Nauru Phosphate Royalties Trust Act 1968* (as amended), including all such moneys coming into the possession of the Garnishee, ARE ATTACHED AND SHALL BE PAID by the Garnishee to the Applicant to answer and fulfill an Order of this Court dated 15 December 1999, against the Respondent, Lucas Depoudu, in favour of the Applicant.


2. The Total Amount Owing to the Applicant by the Respondent under the Court Order is as follows:

(a) Debt amount -	\$8,000.00
(b) Payment made to date -	\$ 900.00
(c) Balance due and owing -	<u>\$7,100.00</u>
<b>Total Amount Owing</b>	<b><u>\$7,100.00</u></b>

3. The Garnishee is **prohibited** from paying all debts due and accruing to the Respondent, or to any other person on his behalf, for the duration of the Order until it is discharged by the Court.
4. The Garnishee shall pay the Applicant, Ruby Thoma, the Total Amount Owing or so much of the amount paid from time to time as may be sufficient to satisfy the Total Amount Owing.
5. The Garnishee shall report to the Court on when the Total Amount Owing plus interest to the Applicant is paid or on so much thereof is paid from time to time to the Applicant and on the balance outstanding. Upon full payment of the Total Amount Owing plus interest, the Garnishee may apply to the Court for the discharge of this Order and shall give notice to the Applicant of such an application to the Court.
6. The Respondent is at liberty to apply to the Court to review the Order.
7. There is no order as to costs.
