The Cabinet makes the following Regulations under Section 66 of the Trademarks Act 2019:

#### 1 Citation

These Regulations may be cited as the *Trademarks (Forms and Fees) (Amendment) Regulations 2022.* 

#### 2 Commencement

These Regulations commence on the day they are notified in the Gazette.

## 3 Amendment of Trademarks (Forms and Fees) Regulations 2020

These Regulations amend the Trademarks (Forms and Fees) Regulations 2020.

### 4 Amendment of Regulation 5

Regulation 5 is amended by deleting the current provision and substituting as follows:

- '(1) For the purposes of Section 9 of the Act, an application for registration of a trademark shall be made for one class of goods or services which shall be in Form 1 of Schedule 2.
- (2) For the purpose of Section 9(1)(f) of the Act, the goods and services submitted for trademark registration shall be classified using the Nice Classification established by the Nice Agreement (1957).
- (3) For the purpose of subregulation (2), 'Nice Agreement (1957)' means the Nice Agreement concerning the International Classification of Goods and Services for the purposes of the Registration of Marks (1957).
- '(4) For the purposes of Section 35 of the Act, the prescribed annual fee for maintaining a trademark is set out in Schedule 3.'.

### 5 Amendment of Schedule 2

Schedule 2 is deleted and substituted as follows:
