ROAD TRAFFIC SIGNS

"S T O P S I G N"

In exercise of the powers conferred on me by Section 43(1) of the Motor Traffic Act 1937-1972 I hereby revoke the meaning of "Stop Sign" as designated in Gazette Notice No. 120/1967 and substitute the following meaning in its stead :

STOP SIGN

Meaning : Stop at the Sign and give way to traffic coming from your left and right before proceeding.
