NOTICE OF AMOUNTS FIXED AS LEGAL TENDER UNDER SECTION 6(2)

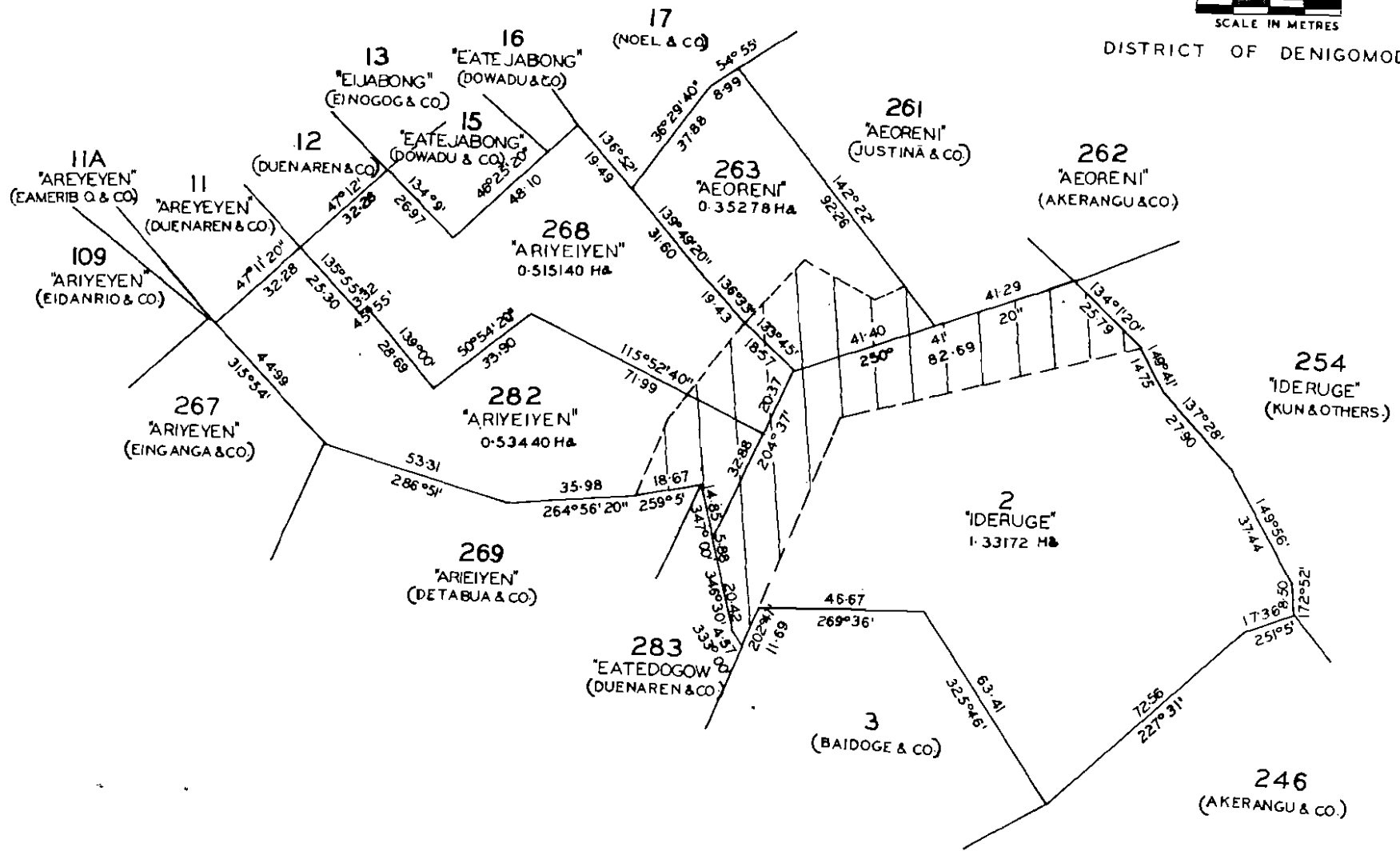
Any person who is dissatisfied with the determination of the above lands may appeal to the Supreme Court within 21 days of the publication of this notice.

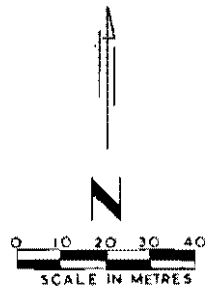


DISTRICT OF DENIGOMODU



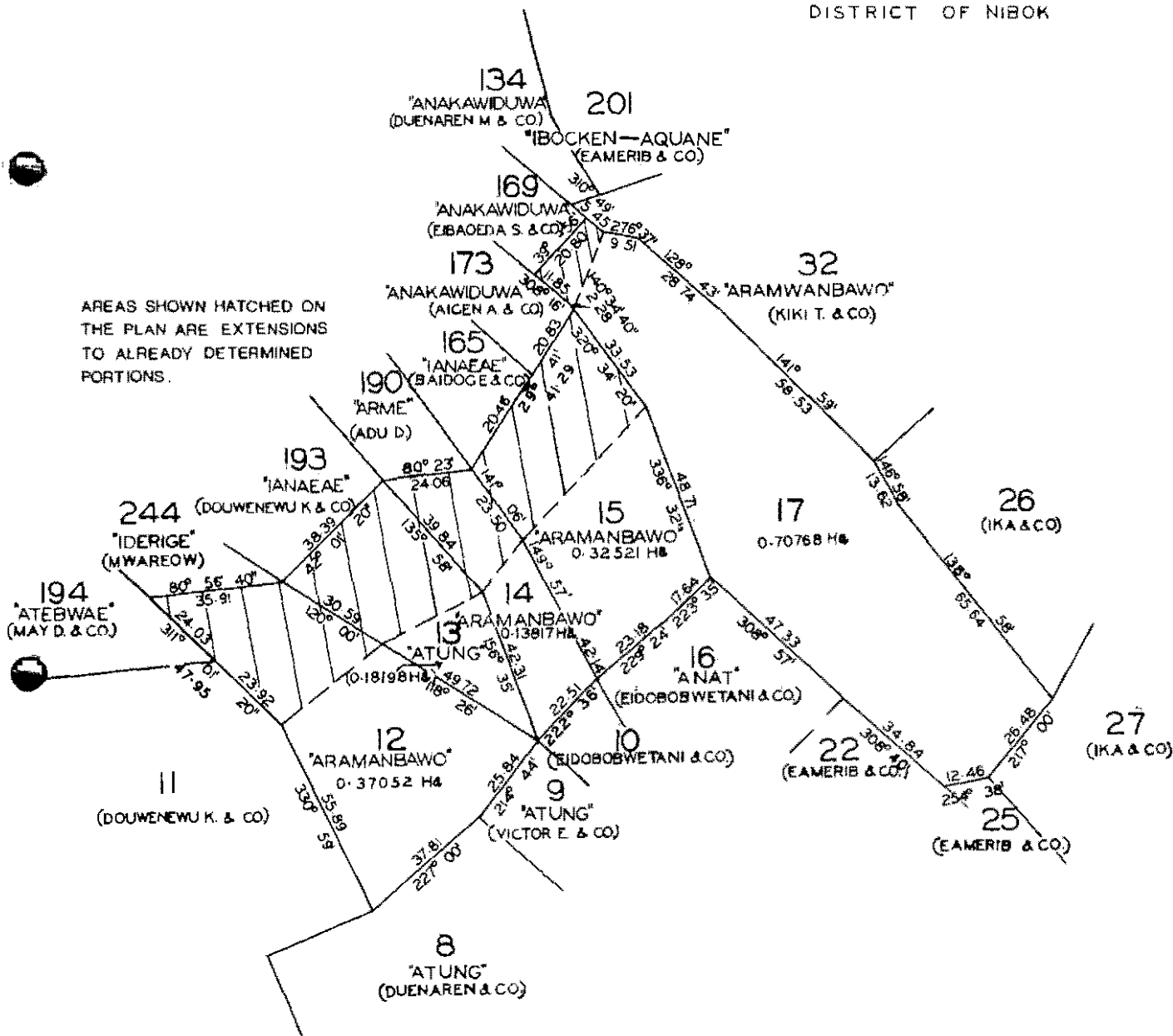
AREAS SHOWN HATCHED ON THE PLAN ARE EXTENSIONS TO ALREADY DETERMINED PORTIONS.

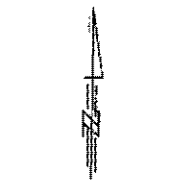


DISTRICT OF NIBOK

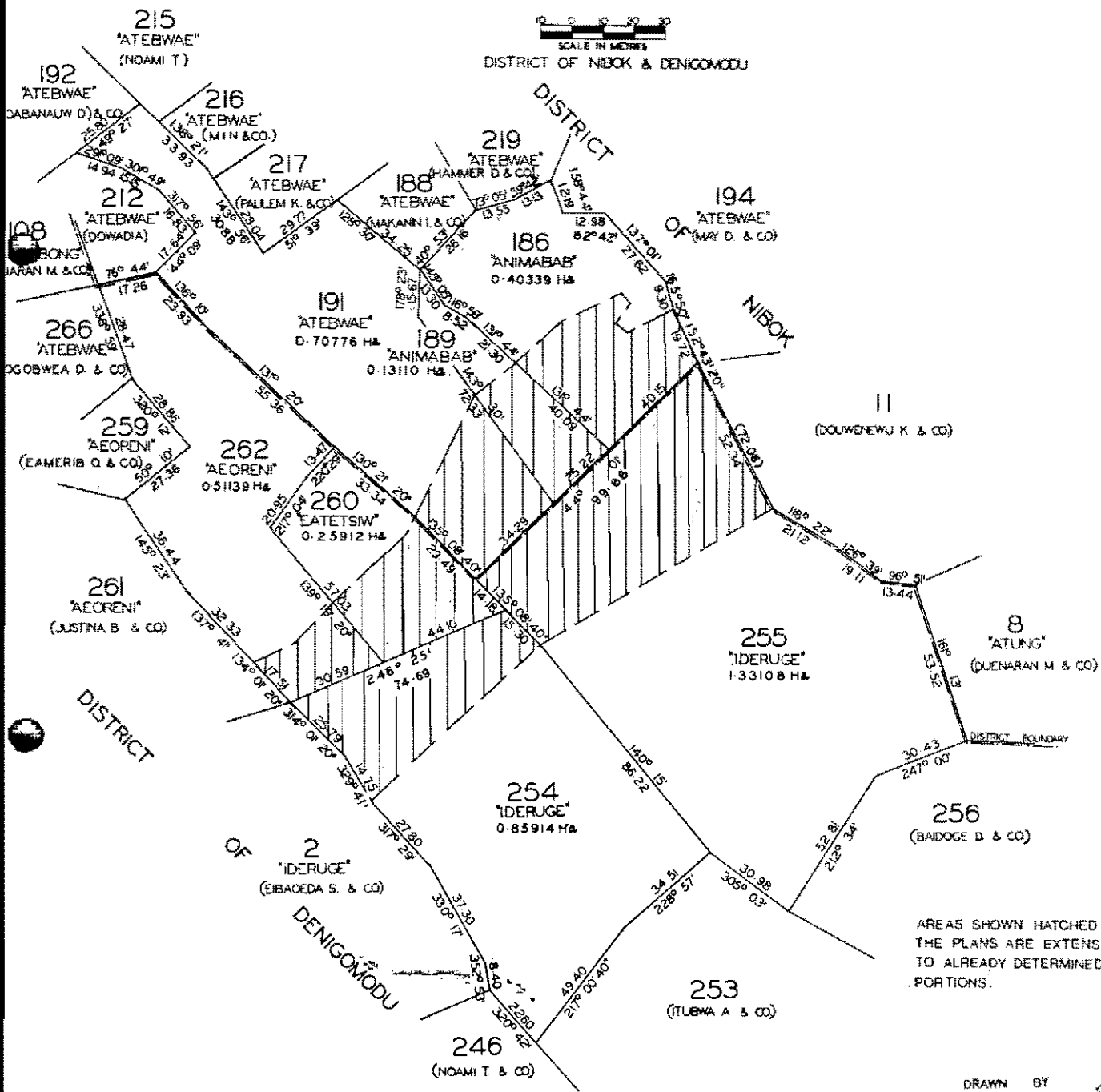
AREAS SHOWN HATCHED ON THE PLAN ARE EXTENSIONS TO ALREADY DETERMINED PORTIONS.



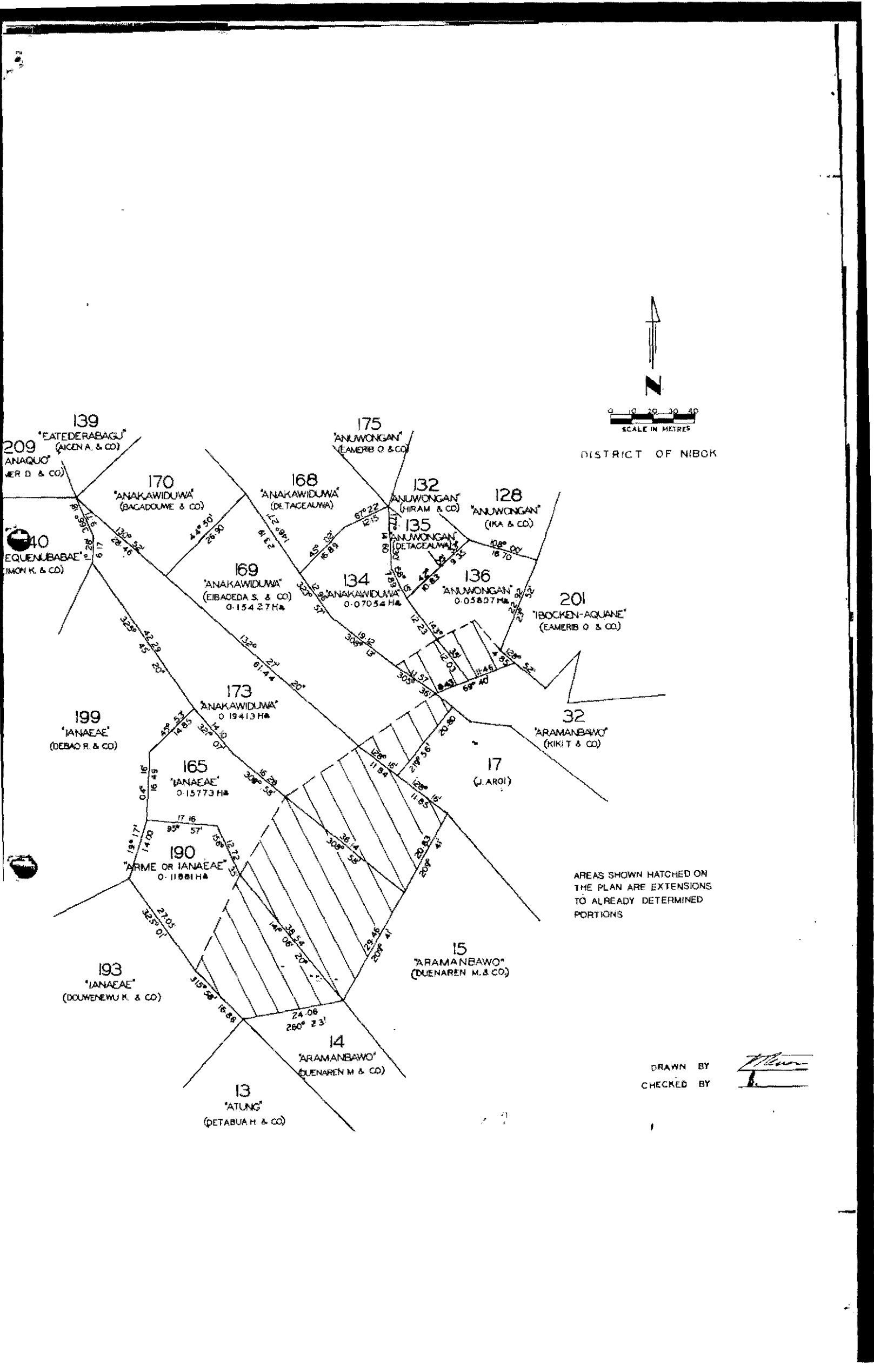

DISTRICT OF NIBOK & DENIGOMODU

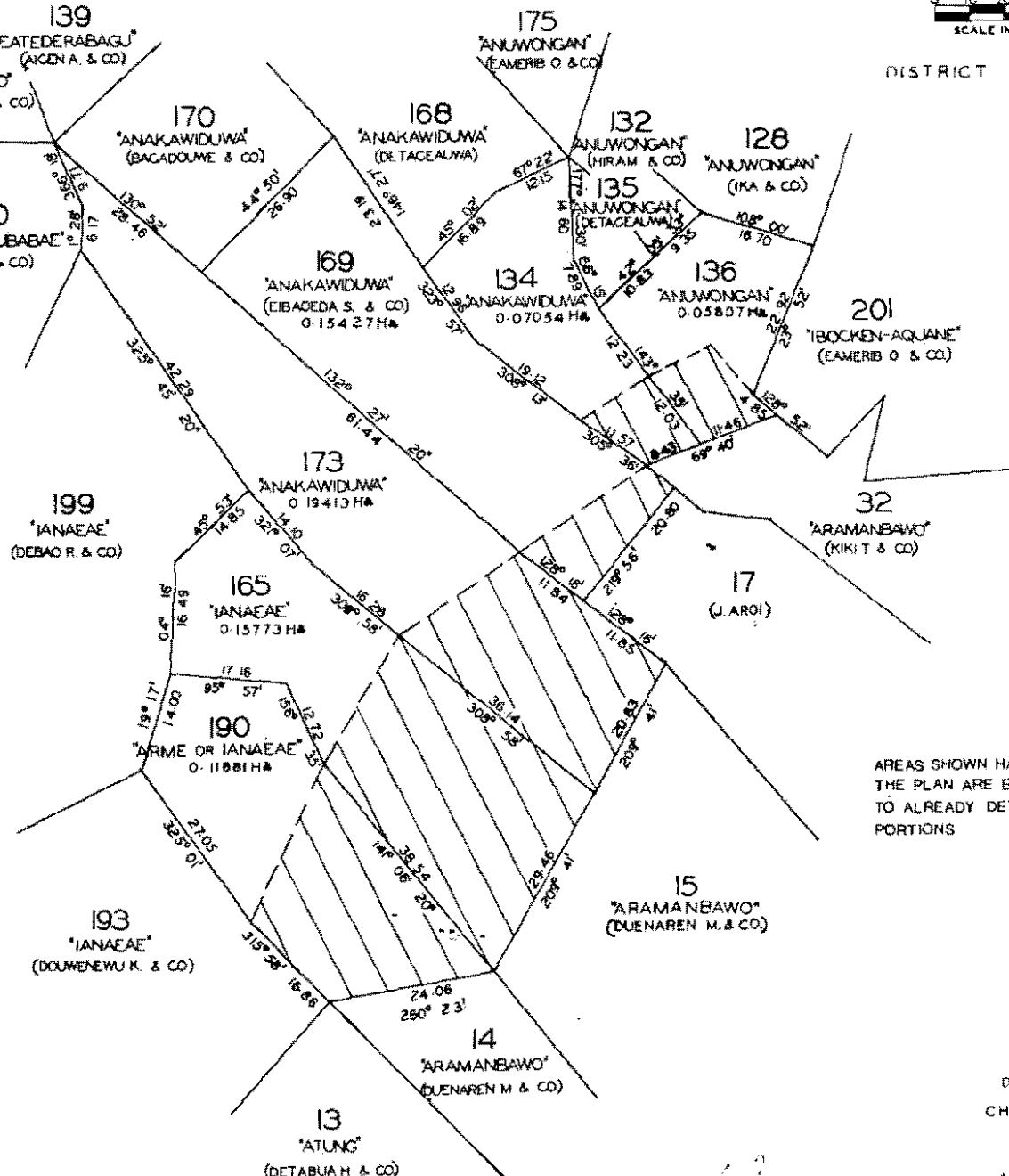
