### ASSIGNMENT OF RESPONSIBILITY

### FOR BUSINESS OF GOVERNMENT

(ARTICLE 23)

Article 23 of the Constitution of Nauru, I, BERNARD DOWIYOGO, President of the Republic of Nauru, HEREBY ASSIGN to the Ministers of Cabinet of Nauru as set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names:

MINISTER OF CABINET

BUSINESS OF GOVERNMENT

Acting President

The Portfolio of the Minister for Justice, External Affairs, Public Service, in relation to the business of Government to be undertaken in Nauru by the said Minister.

Minister for Finance

The Portfolio of the Minister for Works & Community Services in relation to the business of Government to be undertaken in Nauru by the said Minister.

The assignment of the business of the Government of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Ministers.

The above assignments of responsibility for the business of Government of Nauru shall be effective during the absence from the Republic of His Excellency President Bernard Dowiyogo, M.P., and the Honourable Leo Keke, M.P.
