THE CONSTITUTION OF NAURU
ASSIGNMENT OF RESPONSIBILITY
FOR BUSINESS OF GOVERNMENT

(ARTICLE 23)

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU HEREBY ASSIGN TO THE MINISTERS OF CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES :

MINISTER OF CABINET

BUSINESS OF GOVERNMENT

MINISTER FOR JUSTICE

THE PORTFOLIO OF THE MINISTER OF HEALTH AND EDUCATION

MINISTER FOR FINANCE

THE PORTFOLIO OF THE MINISTER FOR ISLAND DEVELOPMENT AND INDUSTRY.

THE ASSIGNMENT OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF THE GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS.

THE ABOVE ASSIGNMENTS OF RESPONSIBILITIES OF THE GOVERNMENT OF NAURU SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HON. J.D. AUDO, M.P. MINISTER FOR HEALTH AND EDUCATION AND HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, O.B.E., M.P., WHO HOLDS THE PORTFOLIO OF ISLAND DEVELOPMENT AND INDUSTRY.
