CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR BUSINESS OF GOVERNMENT

(ARTICLE 23)

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU HEREBY ASSIGN TO THE MINISTERS OF CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES :

MINISTERS OF CABINET

BUSINESS OF GOVERNMENT

MINISTER FOR WORKS & COMMUNITY SERVICES

THE PORTFOLIO OF THE PRESIDENT, EXTERNAL AFFAIRS, INTERNAL AFFAIRS AND THE PUBLIC SERVICE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

MINISTER FOR FINANCE

THE PORTFOLIO OF THE MINISTER OF ISLAND DEVELOPMENT AND INDUSTRY IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

MINISTER FOR HEALTH & EDUCATION

THE PORTFOLIO OF THE MINISTER FOR JUSTICE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF THE GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, O.B.E., M.P. AND THE HON L.D. KEKE, M.P., MINISTER FOR JUSTICE.
