SCALE 1:500

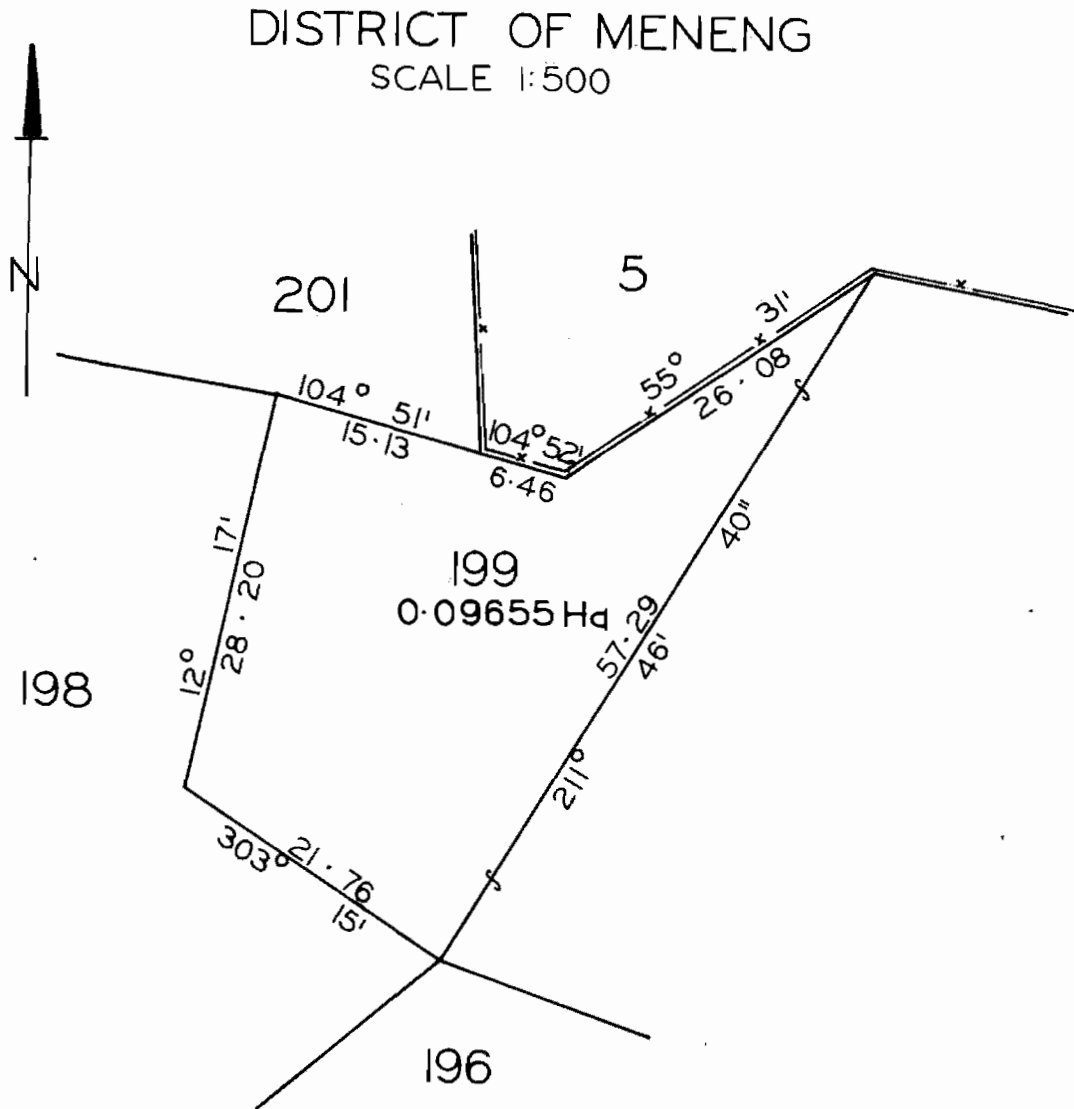

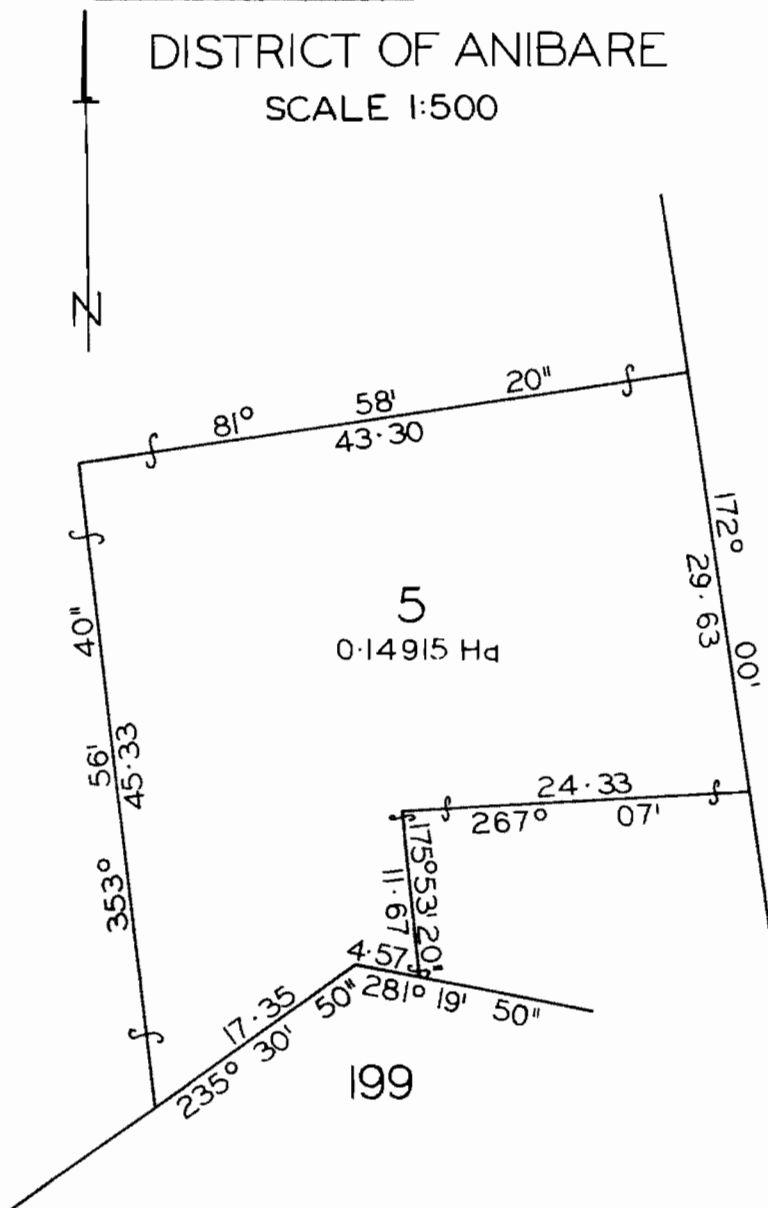



