CONSTITUTION OF NAURU

ARTICLE 25

POST OF CHIEF SECRETARY OF NAURU

The Cabinet invites written applications for appointment to the post of Chief Secretary of Nauru. The appointment will be made by the cabinet under Article 25 of the Constitution.

DUTIES:

The Chief Secretary has such powers and functions as the Cabinet directs and as are conferred on him by the Constitution or by law. He may expect to be appointed Public Service Commissioner and Secretary to the Cabinet. Under the Births, Deaths and Marriages Ordinance he is ex officio, Registrar of Births, Deaths and Marriages.

The Chief Secretary is the Chief policy adviser to Cabinet and may expect to be required to advise the Cabinet on a wide range of matters, including particularly those relating to the organisation and management of the Public Service. He will be responsible for co-ordinating the work of Departments, if required by the Cabinet, and for ensuring the implementation of Government's policies.

The Chief Secretary will be responsible to His Excellency the President for the Work of the Chief Secretary's Department which includes all personnel matters within the Public Service and Information and Broadcasting. Under Article 68 of the Constitution the Chief Secretary is responsible for making appointments of persons to the Public Service, removing them from office, and for disciplinary control over the Public Service.

QUALIFICATIONS:

A good standard of education, considerable administrative ability and an ability to communicate effectively are required for the successful applicant, who will also be expected to have had considerable experience at a high level of the workings of a government in an administrative position. A tertiary qualification in an appropriate discipline would be welcomed, but is not essential.

SALARY:

To be negotiated.

Applications which must be in writing should be sent or delivered to the Chairman of the Cabinet, President's Office, Nauru in an envelope marked "Confidential - Post of Chief Secretary" so as to reach the Chairman of the Cabinet on or before 30th November 1980.

PUBLIC SERVICE ACT 1961-1979

SECTION 15 (1)

CREATION AND ABOLITION OF OFFICES

DIRECTORATE OF HEALTH

I, Hammer DeRoburt, Minister Responsible for the Public Service, in exercise of my powers under Section 15 (1), (3) and Section 15 (4) (b) of the Public Service Act 1961-1979, hereby vary offices in the Directorate of Health as follows:

(a) The office of Dental Mechanic to be redesignated Dental Technologist and to be classified in the range T6/T7/T8. (\$6110 - \$6014)

(b) New office of Dental Technician to be created and classified in the range T4/T5. (\$5498 - \$6014)

(c) The office of Trainee Dental Mechanic to be redesignated Assistant Dental Technician and to be classified in the range T2/T3. (\$4766 - \$5426)

The above variations will have effect from the 1st July, 1980.
