ALTERATIONS IN OFFICES AND APPROVAL FOR A SPECIAL ALLOWANCE

It is notified that the President, His Excellency Hammer DeRoburt O.B.E., M.P, pursuant to Section 15 of the Public Service Act 1961-1979, has made the following changes in offices in the Directorate of Education, Department of Health and Education, with effect from 24 January 1981.

Abolition of an Office (S.15(1)(b))

One position in the Office of Teacher, Scale T4/T8, abolished.

Creation of an Office (S.15(1)(a))

The Office of Senior Mistress, Nauru Secondary School, salary AP.5 fixed at the second point, created.

Raising the Classification of an Office (S.15(1)(c))

The classification of the Office of Deputy Headmaster raised from AP.5 fixed at the second point to AP.5 fixed at the third point.

Altering the Designation of Offices (S.15(d))

The Office of Headmaster redesignated as Principal.
The Office of Deputy Headmaster redesignated as Deputy Principal.
The Office of Chief Instructor Trade School redesignated as Principal.

It is further notified that His Excellency the President, pursuant to Section 38 of the above Act, has approved the payment of a Special Allowance of \$200 per annum to one Teacher at Nauru Secondary School to carry out the duties of Careers Advisor as part of his/her overall duties.
