CRIMINAL PROCEDURE ACT 1972

SECTIONS 47 & 48

DELEGATION OF DIRECTOR OF PUBLIC PROSECUTIONS'  
POWERS AND APPOINTMENT OF PUBLIC PROSECUTOR.

I, VENKATESWARA SUBRAMANIAN MANI, in exercise of my powers under Section 47 of the Criminal Procedure Act 1972, authorise that all or any of the powers and rights vested in, or duties imposed upon me, by Section 46, 180, 181, 182 and 185 of the Criminal Procedure Act 1972, may be exercised by ANTHONY DETSIMEA AUDOA, a Public Officer of the Department of Justice, and so that the exercise of those powers and rights and the performance of those duties by the said ANTHONY DETSIMEA AUDOA in my name shall then operate as if they had been exercised or performed by me PROVIDED that I shall not cease to be able to exercise any of my powers by reason only of I having made this authorization.

FURTHER, AND IN EXERCISE of my powers under Section 48(1) of the Corporation Act 1972, I APPOINT the said ANTHONY DETSIMEA AUDOA, being a Public Officer of the Department of Justice, who is qualified to be admitted to practise as a Barrister and Solicitor, to be a Public Prosecutor generally.
