DEPARTMENT OF HEALTH AND EDUCATION

(Directorate of Education)

- POSITION : CURRICULUM OFFICER - Trade School Course Development.
- SALARY : \$8958-\$10086 p.a. (AP4/5)
- DUTIES : The development of a detailed set of syllabi in a broad range of trade subjects. These would need to specify graduation requirements and contain the weekly or fortnightly objectives for each student. The courses would combine theory with on the job training. The Curriculum Officer would be attached to the Nauruan Trade School but would be expected to liaise with the Secondary School and employer groups.
- QUALIFICATIONS : A teacher qualified in senior technical education is preferred.
- EXPERIENCE : A strong trade background with a broad spectrum of experience is required. Some trade teaching experience would be highly desirable. Experience in writing or modifying syllabi would be helpful.
  
- POSITION : CURRICULUM OFFICER - Infant and Junior Language Development.

- DUTIES : To develop suitable curricula and materials for TESOL that are suited to local conditions. To help coordinate the production of a series of infant readers written in the Nauruan language.
- QUALIFICATIONS : Qualified primary teacher preferably with specialist qualifications for TESOL (Teaching English as a Second Oral Language).
