(Directorate of Civil Aviation)

The Department of Civil Aviation has vacancies for Air Hostesses and invites applications from young Nauruan women who are willing to undergo training as Air Hostesses with a view to employment by Air Nauru. They should, however, be without dependent children.

POSITION : Air Hostesses

ELIGIBILITY : Applicants must:
(a) be at least eighteen (18) years of age
(b) supply particulars of their educational standard and present and/or previous employment.

Members of the Public Service are eligible to apply.

REQUIREMENT OF TRAINING:

Acceptance for training as an Air Hostess does not in itself mean that applicants will be appointed to the Public Service. Those who complete the course successfully will however be eligible for employment in Air Nauru, whether on a permanent or temporary basis.

Training will be undertaken in Nauru, with the exception of some particular procedures, which will be undertaken in Australia or New Zealand. While undergoing training overseas, successful applicants will be provided with accommodation and a subsistence allowance.

SALARY : On appointment as Air Hostesses after completion of training they will be paid commencing salaries as follows:

18 years of age : 4706 P.A.
19 years of age : 5491 P.A.
20 years of age : 7060 P.A.
21 years of age : 7844 P.A.

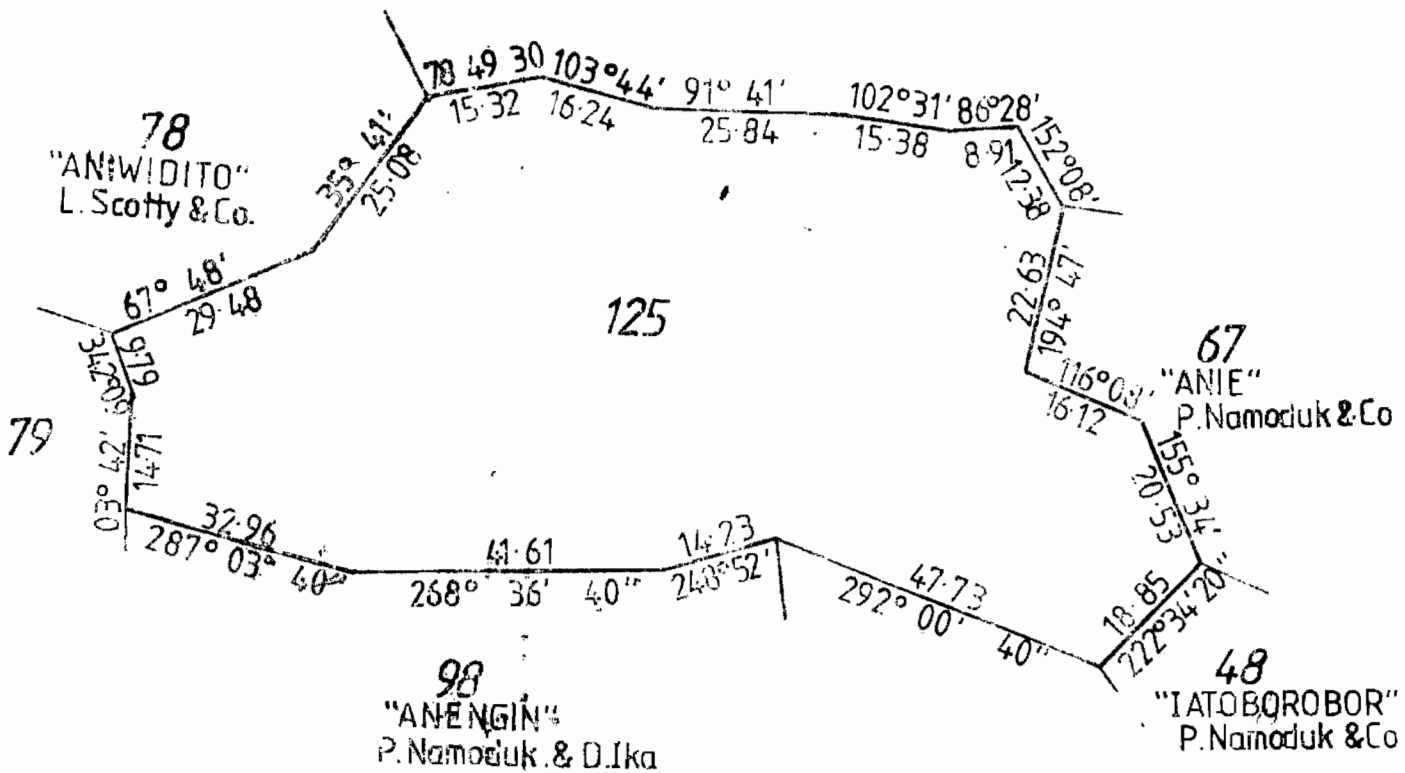
