DECLARATION OF THE RESULTS

NOTICE UNDER SECTION 33 OF N.L.G.C. ACT 1951-1985

PURSUANT to Section 33 of the Nauru Local Government Council Act 1951-1985, I, NIKHIL CHANDRA, Returning Officer, for the 11th General Election of the Councillors to the Nauru Local Government Council held today, the 16th November, 1991, do hereby determine and declare the results of the elections of the Councillors with votes cast :-
