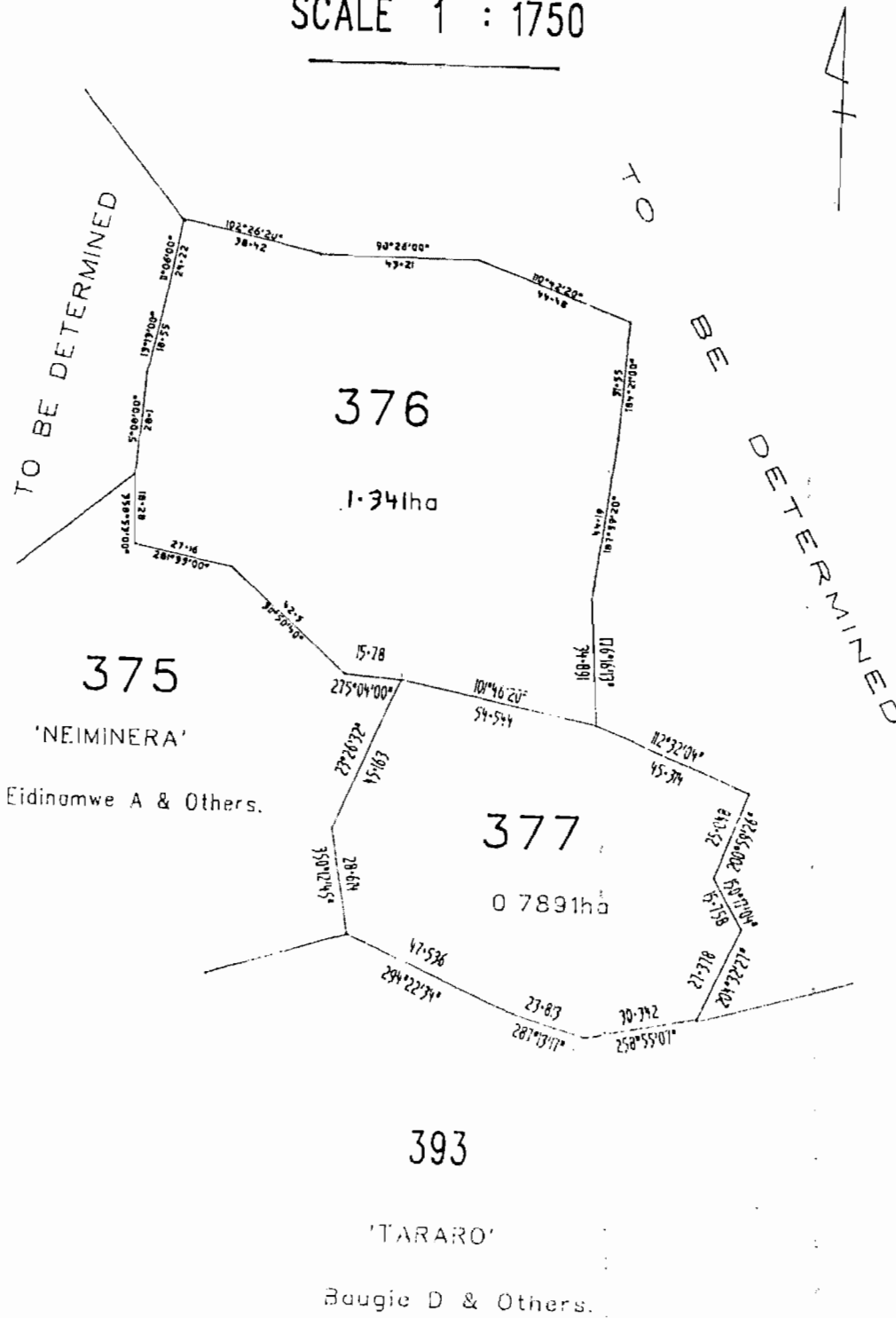

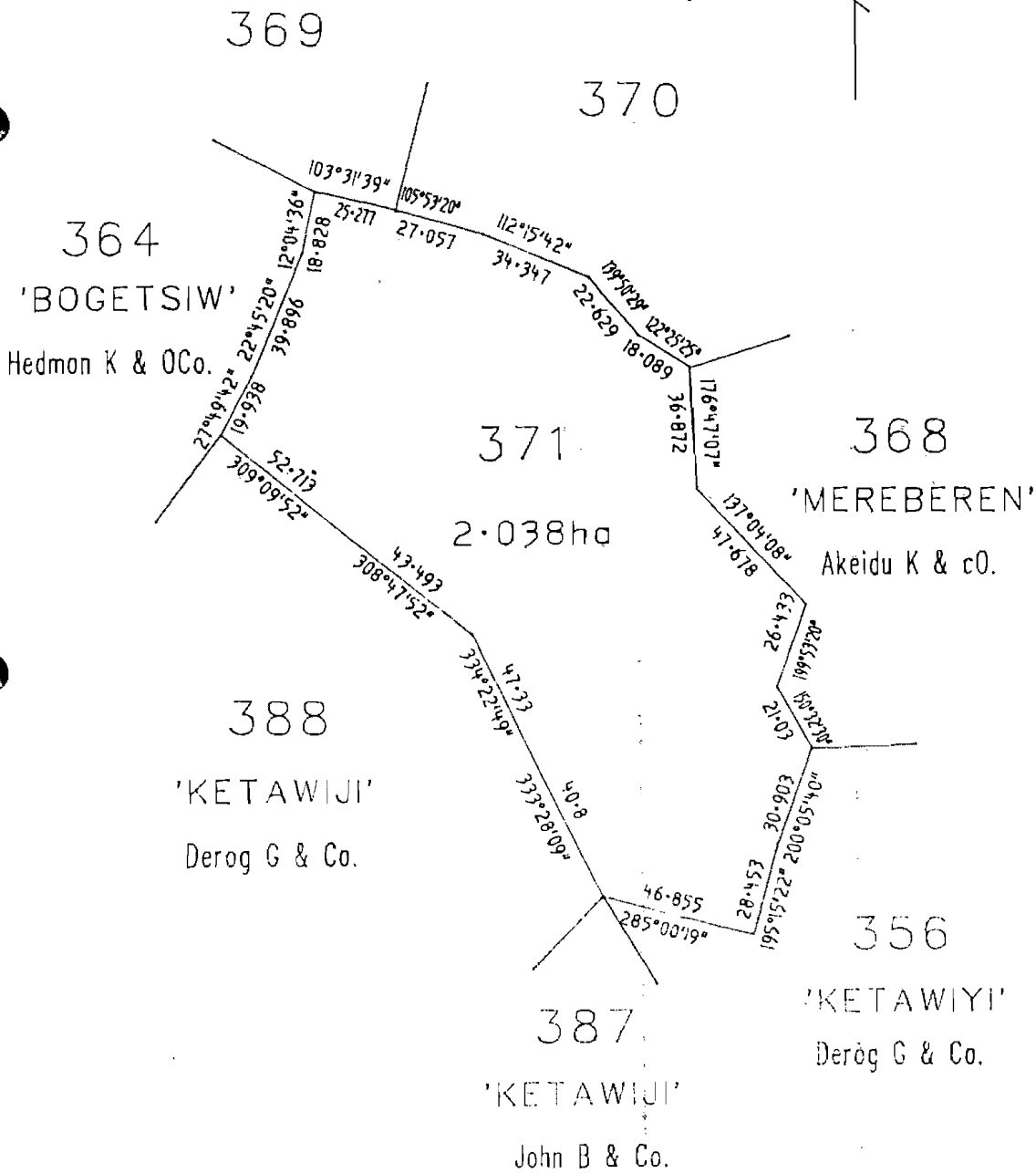

SCALE 1 : 1750



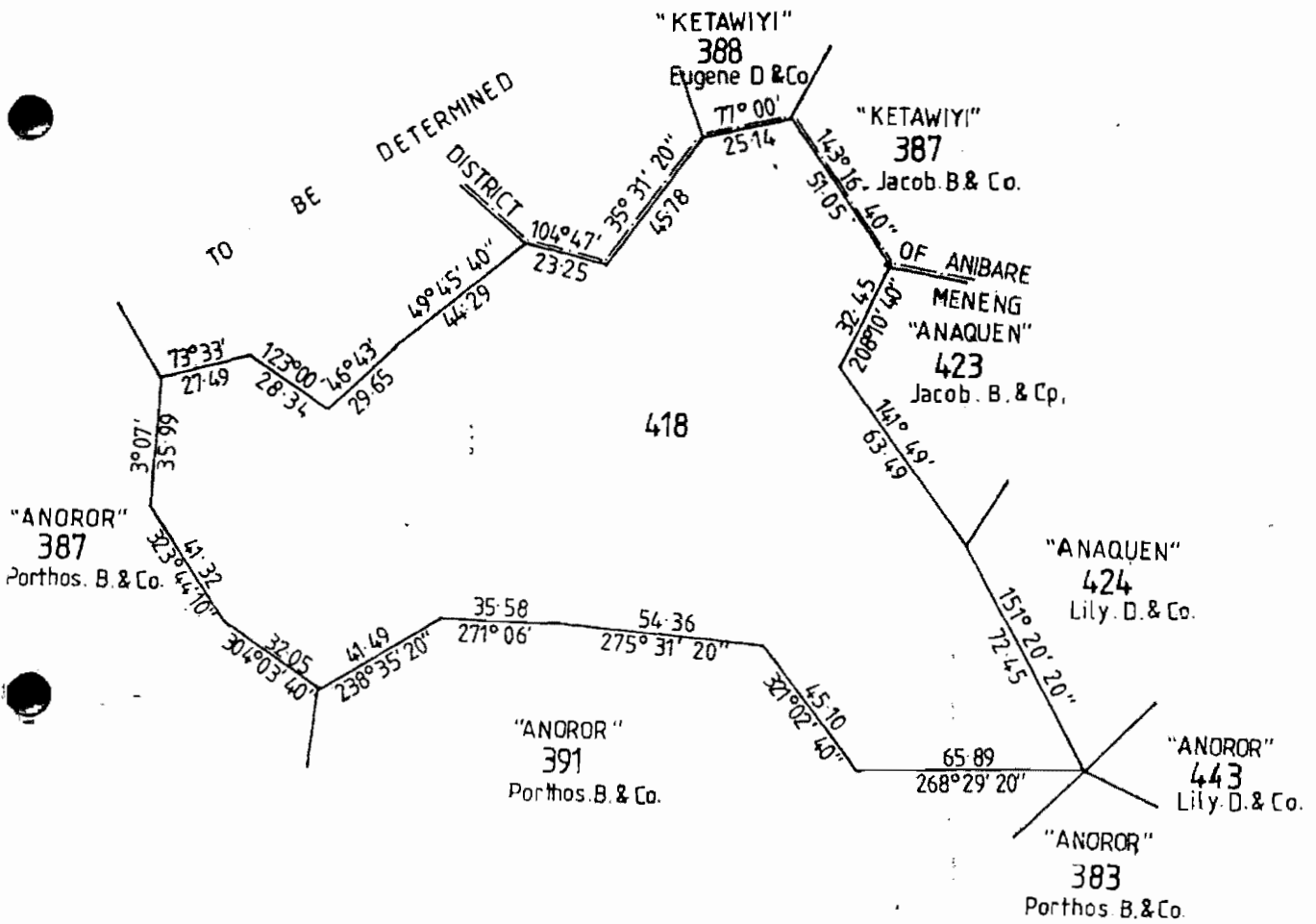
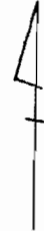
DISTRICT OF ANIBARE  
SCALE 1 : 2000





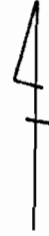
DISTRICT OF MENENG

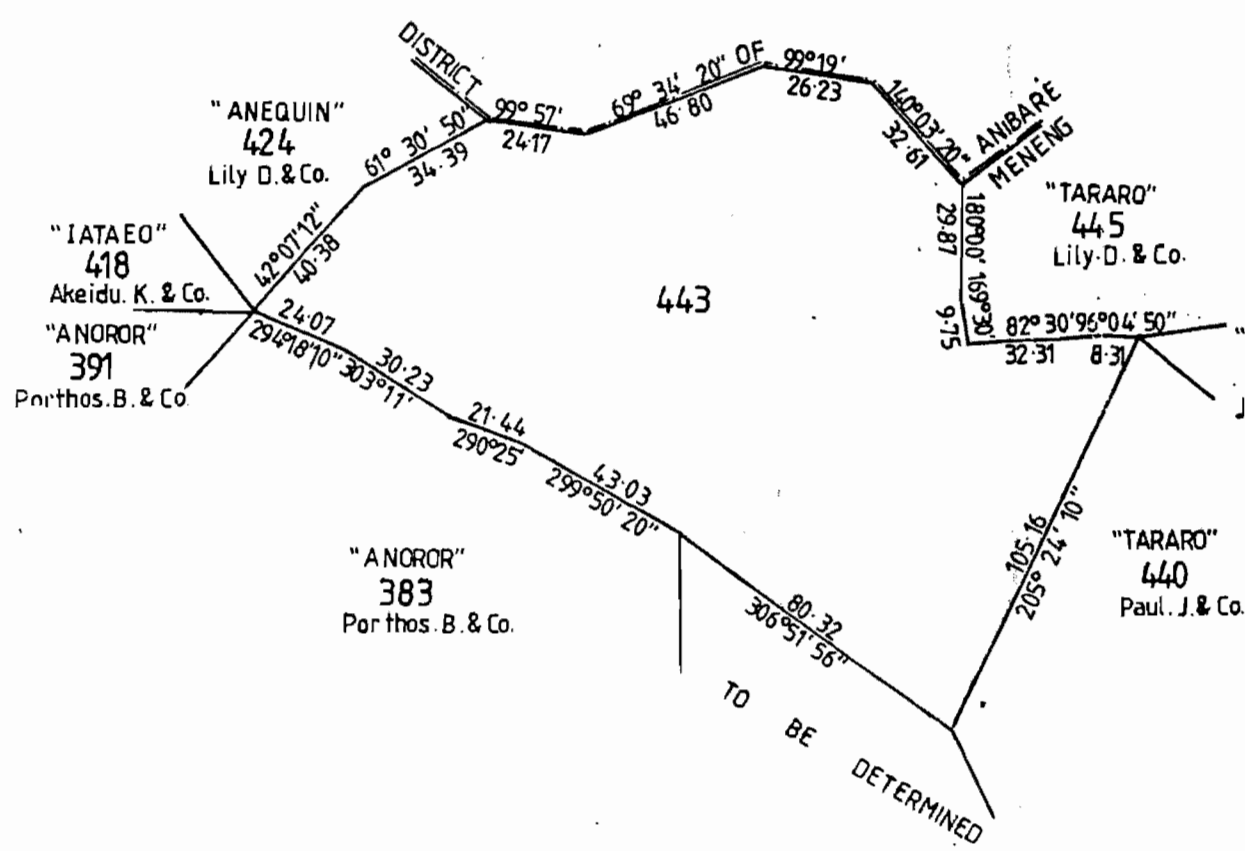

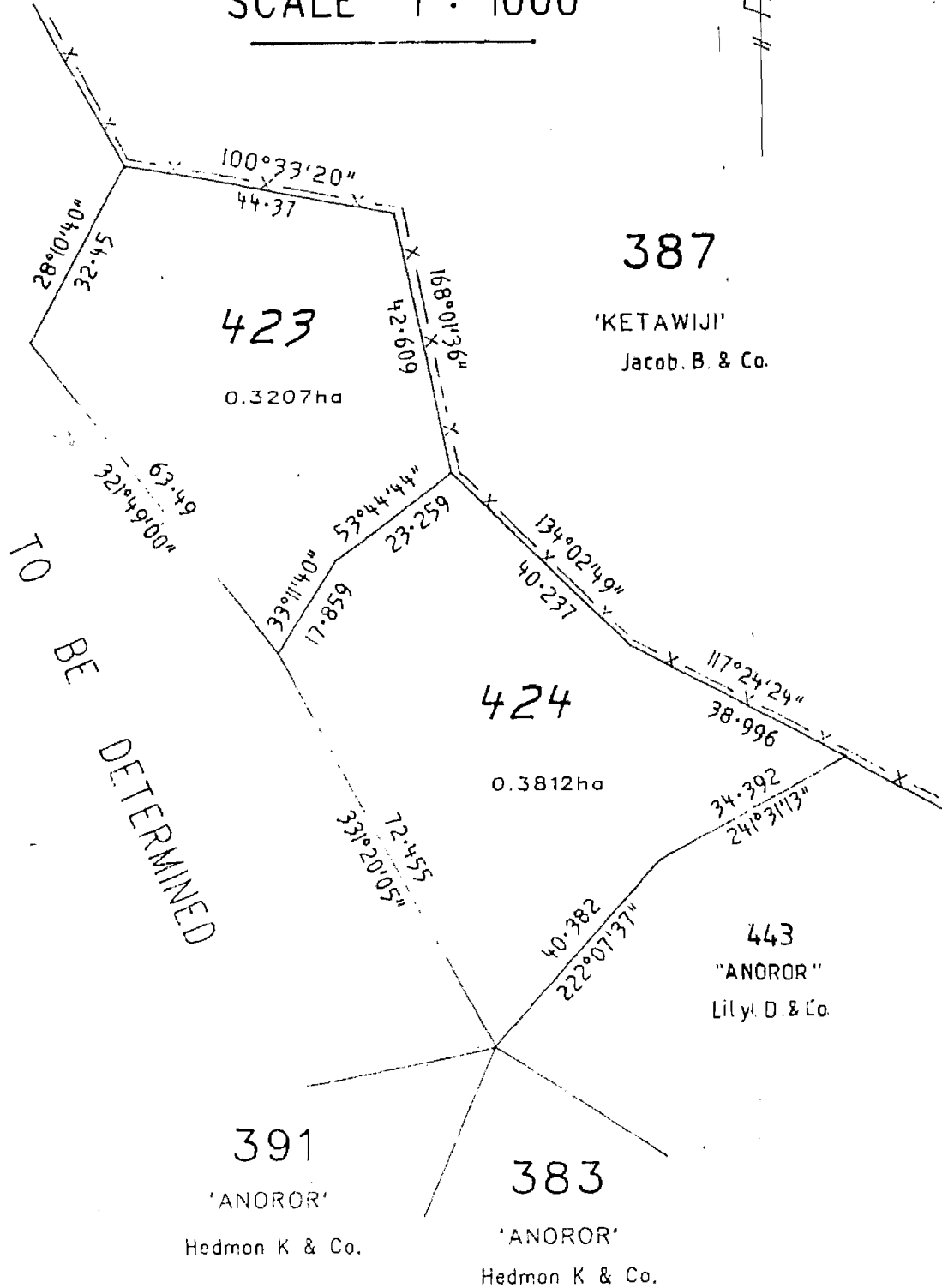
