CONSTITUTION OF NAURU
ARTICLE 23
ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BERNARD DOWIYOGO, M.P., PRESIDENT OF THE REPUBLIC OF NAURU, DO HEREBY, WITH IMMEDIATE EFFECT, ASSIGN TO THE MINISTERS NAMED BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-

MINISTERS OF CABINET

HIS EXCELLENCY BERNARD DOWIYOGO M.P.

BUSINESS OF GOVERNMENT

THE RESPONSIBILITIES FOR THE PORTFOLIOS OF THE PRESIDENT, ISLAND DEVELOPMENT AND INDUSTRY, CIVIL AVIATION AUTHORITY, EXTERNAL AFFAIRS AND PUBLIC SERVICE.

THE HONOURABLE VINSON DETENAMO M.P.

THE RESPONSIBILITIES FOR THE PORTFOLIO OF INTERNAL AFFAIRS, WORKS & COMMUNITY SERVICES, SPORTS AND ANY MATTERS AS MAY BE DELEGATED BY THE PRESIDENT UNDER THE PORTFOLIO OF MINISTER ASSISTING THE PRESIDENT.

THE HONOURABLE KINZA CLODUMAR M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF FINANCE.

THE HONOURABLE VINCI CLODUMAR M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF EDUCATION.

THE HONOURABLE LUDWIG SCOTTY M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF HEALTH.

THE HONOURABLE DEROG GIOURA M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF JUSTICE.

THE ABOVE ASSIGNMENT SHALL BE EFFECTIVE FROM 13TH NOVEMBER, 1996, UNTIL REVOKED OR VARIED, IN ACCORDANCE WITH ARTICLE 23 OF THE CONSTITUTION.
