**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF
GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE VASSAL GADOENGIN, M.P., BEING THE MINISTER FOR JUSTICE AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY THE PRESIDENT, THE HON. BERNARD DOWIYOGO, M.P., FROM THE REPUBLIC.

ARTICLE 23

**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF
GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BERNARD DOWIYOGO, M.P., PRESIDENT OF NAURU, HEREBY ASSIGNS TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:

BUSINESS OF GOVERNMENT

THE PORTFOLIO OF THE MINISTER FOR FINANCE AND ECONOMIC REFORMS, PUBLIC SERVICE, HUMAN RESOURCES DEVELOPMENT AND EMPLOYMENT, FOREIGN AFFAIRS, NAURU PHOSPHATE ROYALTIES TRUST, NAURU FISHERIES AND MARINE RESOURCES, NAURU CITIZENS' INVESTMENT PROGRAM, THE TELECOMMUNICATIONS, NAURU REHABILITATION CORPORATION, CIVIL AVIATION AUTHORITY, NAURU LANDS COMMITTEE, MINISTER FOR HEALTH IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN BY THE SAID MINISTER.

THE PORTFOLIO OF THE MINISTER ASSISTING THE PRESIDENT, WORKS, PLANNING AND HOUSING DEVELOPMENT, SPORTS, GOOD GOVERNANCE, WOMEN'S AFFAIRS IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN BY THE SAID MINISTER.

THE PORTFOLIO OF THE MINISTER FOR INDUSTRY & ECONOMIC DEVELOPMENT, CIVIL AVIATION AND TRANSPORT, WORLD CHAMPIONSHIP 2001, BUSINESS DEVELOPMENT AND CONSUMER AFFAIRS, LANDLEASES NEGOTIATION AND TOURISM IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN BY THE SAID MINISTER.

THE PORTFOLIO OF THE MINISTER FOR EDUCATION & VOCATIONAL TRAINING, YOUTH DEVELOPMENT, HOME AFFAIR'S & CULTURE IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN BY THE SAID MINISTER.

THE ASSIGNMENTS OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE ARE IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY THE PRESIDENT, THE HONOURABLE BERNARD DOWIYOGO, M.P., FROM THE REPUBLIC.
