**SUPREME COURT OF NAURU
PRACTICE NOTE No. 2 OF 2003**

CIVIL PROCEEDING AGAINST THE REPUBLIC

1. Owing to the steps that need to be taken, I have instructed Court staff that no Civil proceedings against the Republic should be issued out of the Court Registry without the prior authorization of the Registrar of the Supreme Court.
2. Practitioners or litigants in person who wish to commence such proceeding should make an appointment with the Registrar.
3. At the meeting, the Registrar will require to view the relevant court documents that are to be issued together with a short clear statement how such a proposed proceeding falls with the provision to Section 3 of the Republic Proceedings Act 1972. Where leave of Cabinet is required to proceed and this has been obtained, the Registrar will require to see a certificate from the Secretary of the Cabinet that leave has been granted pursuant to the Order 50 Rule 2 of the Civil Procedure (Amendment) Rules 1972.

G.N.No. 200/2003 (cont'd)

4. The granting of authorization by the Registry enables the proceedings to issue out of the Court Registry but does not bind the Court upon the hearing of the civil suite.
5. Practitioners and litigants in person are reminded that in any civil proceedings against the Republic the following procedural legislation, regulations and rules have application.
 - a. Republic Proceeding Act 1972
 - b. Proceedings against the Republic Regulations 1973
 - c. Civil Procedure Rules 1972 and particularly the Civil Procedure (Amendment) Rules 1972, Order 50.
6. This Practice Note is to have immediate effect.
