**TELECOMMUNICATIONS SERVICE TAX ACT 2009**

**DETERMINATION REGARDING THE MODE OF PAYMENT AND COLLECTION OF TAX**

Pursuant to the powers vested in me by Section 5 of the *Telecommunications Service Tax Act 2009*, I determine that the following requirements apply to the payment and collection of the Telecommunications Service Tax (the Service Tax) with effect from the 1<sup>st</sup> day of September 2009:

**1. Mode of Payment of the Telecommunications Service Tax:**

Service providers must remit the Service Tax either in cash or via a direct debit transfer to the Government of Nauru Treasury.

Cash payments are to be made to the Revenue Office of the Nauru Department of Finance, (located in the Government Offices, Yaren District).

Payments made by direct debit are to be paid to the Republic of Nauru's main treasury bank account in Australia. Direct debit payments are to include a text note identifying the service provider, the type of tax (TST) and the month for which payment is being made. For example "*Digicel TST Sept 09*".

**2. Monthly Remittance Advice:**

Monthly remittance advices, in the format shown in the Attachment<sup>1</sup>, are to be lodged in hard copy with the Revenue Office of the Nauru Department of Finance (Government Offices, Yaren district) for all payments, on or before the due date for payment.

Remittance advices relating to cash payments are to include a copy of the receipt issued by the Revenue Office on payment of the tax. Remittance advices relating to direct debit payments are to include a hard copy of the electronic receipt issued by the service provider's bank confirming successful processing of the direct debit transaction.

The Monthly Statement required by subsection 4(4) of the *Telecommunications Service Tax Act 2009* detailing the service provider's monthly sales, is to be lodged with the monthly remittance advice.

**3. Nil Remittance Advice:**

Where a service provider receives no revenue in respect of telecommunications services for a particular month the service provider is to lodge a nil remittance advice.

Nil remittance advices are to be lodged in hard copy with the Revenue Office of the Nauru Department of Finance (Government Offices, Yaren district) on or before the last day of the month following the month to which the nil remittance advice applies.

**4. Official Receipt**

The Nauru Department of Finance is to issue an official receipt to the service provider in respect of each payment of the Service Tax received from the provider.
