Cabinet makes the following Regulations under section 28 of the Business Licences Act 2017:

1 Citation

These Regulations may be cited as the Business Licences Regulations 2017.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Repeal of Business Licences Regulations 2011

The Business Licences Regulations 2011 are repealed by these Regulations.

4 Licence fees

The prescribed fees to be paid for the purposes of the Act are set out in Schedule 1 of these Regulations.

5 Application form

For section 8 of the Act, the prescribed form for an application for a business licence is set out in Schedule 2.

6 Change of particulars

For section 21 of the Act, the prescribed form for an application for change of particulars of a business is set out in Schedule 3.
