1        **Citation**

These Regulations may be cited as the *Partnership (Fees)(Amendment) Regulations 2018*.

2        **Commencement**

These Regulations commence on the day they are notified in the Gazette.

The *Partnership (Fees) Regulations 2017* are amended by the provisions of these Regulations.
