Cabinet makes the following Regulations under section 102(2)(b) of the *Births Deaths and Marriages Registration Act 2017*:

**1. Citation**

These Regulations may be cited as the *Births Deaths and Marriages Registration (Forms) (Amendment) Regulations 2019*.

**2. Commencement**

These Regulations come into effect on the day they are notified in the Gazette.

**3. Amendment of Births Deaths and Marriages Registration (Forms) Regulations 2018**

The *Births Deaths and Marriages Registration (Forms) Regulations 2018* are amended by the provisions of these Regulations.
