The Cabinet makes the following Regulations under Section 62 of the *Environmental Management and Climate Change Act 2020*:

1. Citation

These Regulations may be cited as the *Environmental Management and Climate Change (Notices) Regulations 2021*.

2. Commencement

These Regulations come into effect on the day they are notified in the Gazette.

3. Precautionary Notice

For the purposes of Section 43 of the Act, an authorised officer may issue a Precautionary Notice in Form 1 of the Schedule.

4. Notice to Cease

For the purposes of Section 44 of the Act, the Secretary may issue a Notice to Cease an act or activity in Form 2 of the Schedule.

5. Notice to Improve

For the purposes of Section 45 of the Act, an authorised officer may issue a Notice to Improve in Form 3 of the Schedule.

6. Prohibition Notice

For the purposes of Section 46 of the Act, the Secretary may issue a Prohibition Notice in Form 4 of the Schedule.
