The Cabinet makes the following Regulations under Section 12(1)(a) of the *Customs Tariff Act 2014*:

1 Citation

These Regulations may be cited as the *Customs Tariff (Amendment of Schedule 1)(Tariff) Regulations 2024*.

2 Commencement

These Regulations commence on the date they are notified in the Gazette.

3 Amendment of Schedule 1
