AN ORDINANCE

To Validate the Application of the Grant to Rubber Growers for the Year ended on the last day of June, One thousand nine hundred and thirty-three, and for the Year ended on the last day of June, One thousand nine hundred and thirty-four.

WHEREAS the moneys received from the Commonwealth Government for the assistance of the rubber growers of the Territory for the year ended on the last day of June, One thousand nine hundred and thirty-three, which moneys amounted to the sum of Seven thousand three hundred and forty-two pounds ten shillings, were paid into a trust fund created for that purpose : Preamble.

AND WHEREAS the moneys received from the Commonwealth Government for the like assistance for the year ended on the last day of June, One thousand nine hundred and thirty-four, which moneys amounted to the sum of Twenty-three thousand two hundred and thirty-seven pounds seven shillings and one penny, were paid into the same trust fund :

AND WHEREAS such moneys as aforesaid should have been paid into the Revenues of the Territory and appropriated therefrom in each of the said years for the assistance aforesaid :

AND WHEREAS it is desirable and necessary that the matter should be sanctioned by an Ordinance :

BE it therefore ordained by the Legislative Council for the Territory of Papua in pursuance of the powers conferred by the *Papua Act, 1905-1924*, as follows :—

Short title.

1. This Ordinance may be cited as the *Application of the Grant to Rubber Growers Validating Ordinance, 1934.*

Assistance to rubber growers for year ended 30th June, 1933, and for year ended 30th June, 1934.

2. The sum of Seven thousand three hundred and forty-two pounds ten shillings received from the Commonwealth Government for the assistance of the rubber growers of the Territory for the year ended on the last day of June, One thousand nine hundred and thirty-three, and the sum of Twenty-three thousand two hundred and thirty-seven pounds seven shillings and one penny received from the Commonwealth Government for the assistance of the rubber growers of the Territory for the year ended on the last day of June, One thousand nine hundred and thirty-four, shall be deemed to have been paid into the Revenues of the Territory and appropriated for the purpose of the aforesaid assistance at the times when the various amounts making up the aforesaid sums were received from the said Commonwealth Government.

Officers indemnified.

3. The Lieutenant-Governor and the Treasurer and all other officers are hereby indemnified against all claims and liabilities in respect of the issue and application of the said sums without the previous authority of an Appropriation Ordinance.

Passed in Council this fifth day of September, in the year of Our Lord One thousand nine hundred and thirty-four.
