AN ORDINANCE

Relating to Duties of Customs.

BE it enacted by the Lieutenant-Governor of the Territory of Papua with the advice and consent of the Legislative Council thereof as follows:—

1. (1) This Ordinance may be cited as the *Customs Tariff*, 1928. Short title and citation.

(2) The *Customs Tariff*, 1922, is in this Ordinance referred to as the Principal Ordinance.

(3) The Principal Ordinance as amended by this Ordinance may be cited as the *Customs Tariff*, 1922-1928.

2. The Second Schedule to the Principal Ordinance is amended as set out in the Schedule to this Ordinance except as to anything done before the commencement of this Ordinance and except so far as relates to any arrears of duty and except so far as may be necessary for the purpose of supporting or continuing any proceeding Amendment of Tariff.

heretofore taken or to be taken after the commencement of this Ordinance and Duties of Customs are hereby imposed in accordance with the Second Schedule as so amended.

Date from which new duties and decreased duties are to commence.

3. Subject to this section whereby this Ordinance—

(a) any duty is imposed on any article; or

(b) the duty on any article is decreased,

the duty or decrease of duty shall be deemed to have been imposed as on and from the first day of July, One thousand nine hundred and twenty-eight at ten o'clock in the forenoon reckoned according to the standard time in force in the Territory of Papua and this Ordinance shall be deemed to have come into operation at that time.

Passed in Council this seventh day of June, in the year of Our Lord One thousand nine hundred and twenty-eight.

SCHEDULE.

That the Second Schedule to the *Customs Tariff, 1922*, be amended as hereunder set out and that on and after the first day of July, One thousand nine hundred and twenty-eight Duties of Customs be collected in pursuance of the "*Customs Tariff*" as so amended.

AMENDMENT OF *Customs Tariff, 1922.*

IMPORT DUTIES.

Tariff Item.	Rate of Duty.
8. By omitting the whole of sub-item (c) and inserting in lieu thereof the following sub-item :—	
(c) Australian:—	
(1) Sparkling† per gallon	15s.
(2) Still—in bulk per gallon	2s. 6d.
(3) Still—in bottle§ per gallon	3s. 6d.
(4) Still—containing more than 40 per cent. of proof spirit§ per gallon	15s.

†Three magnums, six reputed quarts, twelve reputed pints, or twenty-four reputed half-pints to be charged as one gallon.

§Six reputed quarts, twelve reputed pints, or twenty-four reputed half-pints to be charged as one gallon.
