Diameter 27.70 mm, standard weight 9.76 grams \pm .19 grams alloy 900/1000 fine gold. The design on the coin obverse is a bird of paradise together with a design of a traditional string of holed coins and the legend "First Anniversary of Independence".

The reverse side will carry the symbol of the Bank of Papua New Guinea and the year of mintage—1976.

The coin will have a round shape with a reeded edge and a central hole of 5.7 mm.
