*Merchant Shipping Act 1975***EXEMPTION**

I, John Crossman Wardle, a delegate of the Minister, by virtue of the powers conferred by Section 103 of the *Merchant Shipping Act 1975*, and all other powers me enabling, hereby exempt, for one year, as from the 20th day of January 1977,

- (1) All vessels of under thirty metres in length which are engaged in the Coastal Trade from complying with the qualifications requirements of the "Manning Scales" as laid down in Schedules 3 and 4 of the Merchant Shipping (Crewmen) Regulation 1976.
- (2) All vessels of between thirty and seventy metres which are engaged in the Coastal Trade from complying with the requirements for qualifications as laid down in Schedules 3 and 4. However, the qualification requirements shall not be less than as follows:
