*Public Service Act* (Chapter 67)

APPOINTMENT OF DEPARTMENTAL HEAD

I, Kingsford Dibela, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Section 57 of the *Public Service Act* (Chapter 67) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby—

- (a) revoke the notice of Appointment of Acting Departmental Heads dated 1st November, 1983 and published in *National Gazette* No. G79 of 10th November, 1984 in so far as it relates to the appointment of Gus Schweinfurth as Acting Secretary, Department of the Morobe Province; and
- (b) appoint John Gaius to the office of Secretary, Department of the Morobe Province for a period of three years commencing on and from 2nd April, 1984.
