## Organic Law on National Elections

### REVOCATION OF APPOINTMENT OF ASSISTANT RETURNING OFFICERS AND APPOINTMENT OF ASSISTANT RETURNING OFFICERS

THE ELECTORAL COMMISSION, by virtue of the powers conferred by Section 19 of the Organic Law on National Elections and all powers it enabling, hereby:

- (a) revokes all previous appointment of Assistant Returning Officers; and
- (b) appoints each person specified in Column 1 of the Schedule to be the Assistant Returning Officers for the Electorate specified in Column 2 and set out opposite the name of that person.
