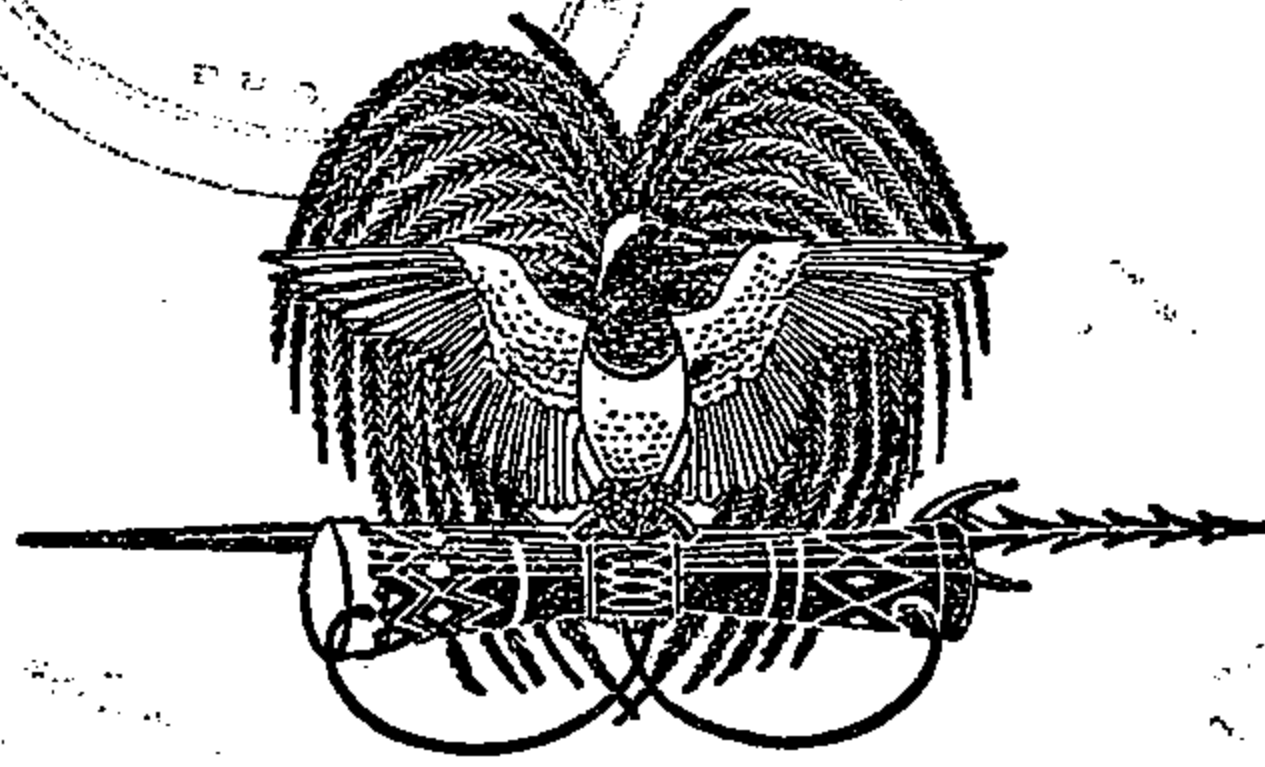

## DELEGATION
