STATUTORY INSTRUMENT**No. 17 OF 1993****Mining (Transitional Provisions) Regulation 1993**

being

A Regulation,

MADE by the Head of State, acting with, and in accordance with, the advice of the National Executive Council under Section 183 of the *Mining Act* 1992 to be deemed to have come into operation on 27th August, 1992.

EXPLORATION AND MINING RIGHTS IN RELATION TO A SPECIAL MINING LEASE

(1) Subject to this Section, a special mining lease issued under the provisions of the repealed Acts and continuing in force under Section 173(2) of the Act is deemed to include the exclusive right to explore for and mine minerals in and under the land the subject of the special mining lease, notwithstanding that—

- (a) any condition in the special mining lease or in the mining development contract or other agreement relating to that special mining lease; or
- (b) the grant of any exploration licence under this Act or prospecting authority under the repealed Acts, has, or would appear to have or have had the effect of precluding or limiting that exclusive right.

(2) The exclusive right referred to in Subsection (1) to explore for minerals and mine minerals, to the extent that it includes rights not granted by a special mining lease prior to the coming into operation of this Regulation, may be exercised only where—

- (a) in respect of any exploration or mining to which an exploration licence under this Act or prospecting authority under the repealed Acts referred to in Subsection (1)(b) applies, that exploration licence under this Act or prospecting authority under the repealed Acts has expired or otherwise has terminated according to law; and
- (b) the conditions of the special mining lease and relevant mining development contract or other agreement have been varied where necessary to provide for the exclusive right, and it is hereby provided that such variation may be made notwithstanding any provision to the contrary in the special mining lease and relevant mining development contract or other agreement.
